1. PROJECT IMPLEMENTATION: 1 – 31 AUGUST 2008

Project activities

1.1.1. Activity 2.1.1 – Regional Thematic Conference

The logistical preparations and identification of experts for the first Regional Thematic Conference on Financial Investigations and Confiscation of Proceeds from Crime have commenced. The Regional Thematic Conference will take place on 25 and 26 September in Cavtat, Croatia. Each project area is expected to nominate 6 representatives, prosecutors and law enforcement officers who are working on issues related to financial investigations and confiscation of proceeds from crime.

1.1.2. Activity 2.2.5 – In-project area training for Serbia

Following a request from the Contact Person from General Prosecutor's Office of Serbia, the Council has commenced with organisation of the Training Seminar on International Co-operation in International Instruments. The Council agreed with the proposal from the Contact Person to organise two one-day Training Seminars in Belgrade and Nis, instead of a one two-day seminar in Belgrade. According to the Contact Person this is the best way to ensure the highest possible attendance of prosecutors from district and municipal public prosecutor's offices. It was agreed that the General Prosecutor's Office sends invitations to the district and municipal prosecutor's offices and submit a list of registered participants to the Council of Europe.
