# International Conference on Extradition Draft Programme

### Objective:

The aim of this conference is to review and discuss problematic issues in relation to extradition under the Convention & Protocols, to propose solutions, exchange best practice and improve the cooperation in this field. The relevant jurisprudence of the European Court of Human Rights as regards extradition will also be examined. Presentations will focus on specific articles of the Convention and Protocols and case studies should be used to highlight operational issues encountered by practitioners.

The conference will also give an opportunity for participants from non-European Union Member States to gain an understanding of the European Arrest Warrant that has been in operation in the Member States of the European Union since 2004.

Finally, in keeping with one of the main project objectives, the conference will provide Ukrainian officials working in this area (from both the central and regional offices) an opportunity to establish, develop and enhance, institutional and personal contacts to assist in the improvement of the Convention and Protocols, by breaking down communication barriers and fostering closer international working relations.
