

Characteristics foreign prisoners

- Foreign status
- Lack of language skills
- **Distance family**
- Cultural and religious differences





Characteristic issues

- Exclusion non-custodial sentences / prison leave
- Lack of information rights / rules
- Discrimination
- No contact diplomatic mission
- Social isolation
- Exclusion from resettlement activities
- Lack of aftercare

Legal protection

Rec(2012)12 European Prison Rules Standard Minimum Rules EU Roadmap on Procedural Rights

- Right to Interpretation and translation
- Right to information about rights and charges
- Right to communicate with relatives, consular authorities

→ Monitoring bodies (national (NPM), CPT, SPT)

Consular assistance

Vienna Convention on Consular Relations (1963)

(46 CoE Member States, except San Marino)

Article 36.1

- a) Consular officers entitled to have free communication + access and allowed to arrange legal representation + provide assistance
 Foreign prisoner has right to make contact and to receive visits
- c) Prison authorities must, upon request, notify consular post





Rec 2012(12)

Rule 22.1

To alleviate the potential isolation of foreign prisoners, special attention shall be paid to the maintenance and development of their relationship with the outside world, including contacts with family and friends, consular representatives, probation and community agencies and **volunteers**.





Key areas of concern

Emotional well-being and treatment Awareness legal proceedings and rights Contact with outside world Social inclusion within prison Preparation for release and aftercare





Good practices

Admission Information leaflet (consular authorities, ngo's) Translation rules (consular authorities, ngo's)

During detention Regular visits (volunteers, clergymen) Oral information (appoint other foreign prisoners 'coordinator') Special visits (consular staff, family) Skype / webcam





Good practices

Preparation release

Visits (consular staff, volunteers)

Skype / webcam

Aftercare Facilities and assistance (NGO Prisoners Abroad) Prison tranfers?
