

In accordance with its terms of reference **2014-2015** and with the decisions made by the Committee of Ministers on 10 April 2013, at the 1168th meeting of their Deputies (item 10.2) regarding the Report by the Secretary General on the Review of Council of Europe conventions, the CDCJ is instructed to carry out, at regular intervals, within the limits of the available resources and bearing in mind its priorities, an examination of some or all of the conventions for which it has been given responsibility (see list below), in co-operation, where appropriate, with the relevant convention-based bodies, and report back to the Committee of Ministers.
