

## **Ongoing and submitted projects in the field of media and freedom of expression online and offline**

**From 1 January 2017 to 30 April 2017**

### **Summary**

Twelve cooperation projects with external funding (voluntary contribution or jointly funded by the European Union) are currently underway amounting to 7 429 398 Euros in all. Some activities are also financed by the ordinary budget of the Council of Europe.

Approximately 129 activities were organised since January 2017. The work in the field of freedom of expression and media freedom encompassed a very broad range of activities such as legal expertise, training programs, seminars, conferences and other events with the participation mainly of public officials, media professionals and civil society. The constant strive to look for links and synergy between the various projects is an added value of cooperation activities. Best practices and results achieved are constantly shared with others through bilateral and regional networking.

### 1. Freedom of expression and media freedom

Main objective	The main objective of the project is to strengthen or establish legal and institutional guarantees for a pluralistic media landscape in the Republic of Moldova.

In particular the project supports the law-makers, policy-makers, members and staff of regulatory bodies, civil society actors and media professionals in (1) drafting amendments to existing media related legislation in line with European standards and (2) putting into practice the regulatory framework.</p> <p><b>Specific objective 2:</b></p> <p>Enhancing the professionalism of public service broadcasters.</p> <p>The Objective 2 is focussed on direct assistance to public service supervisory bodies and to Teleradio Moldova and Teleradio Gagauzia. It is based on three modules focusing on: (1) public service broadcasters' supervisory bodies of Teleradio-Moldova and Teleradio-Gagauzia; (2) public service broadcaster Teleradio-Moldova; (3) public service broadcaster Teleradio-Gagauzia. Supporting the organisation of round-tables and inter-professional meetings to discuss the development and improvement of codes of conduct, specific glossaries and/or handbooks for journalists, photographers and editors dealing with terrorist acts and threats at the national and regional level.

Supporting the organisation of round-tables involving media professionals and all relevant stakeholders such as governmental bodies, regulatory authorities, non-governmental organisations to support collective engagement in constructive dialogue to facilitate the right to freedom of expression when facing terrorism.

Supporting the participations of media professionals in professional networks and the organisation of regional conferences to encourage the co-operation and exchange of experiences between journalists and other media professionals and national media self-regulatory bodies.
