## Re: Loizidou v Turkey, Application no. 15318/89 Judgment of 18.12. 96 (Merits) Judgment of 28/07/1998 (Just Satisfaction)

I refer to my recent visit to Strasbourg with my daughter and I would like to thank you for accepting to see us and discuss the various issues regarding my case.

As you know my case was brought again to the Secretariat of the Committee of Ministers in November 2017 in relation to my application for the continuing violation of my property rights for the period 28 January 1987 – 22 January 1990 (Article 32), as well as in relation to the implementation of the decision of 1996 regarding the individual measures.

During the above meetings we became aware of the 4th December 2008 Committee of Ministers' prima facie decision regarding the individual measures and the Secretariat's recommendation to the Committee of Ministers to close the case.

In light of the above and following our request to the Permanent Representatives to the Council of Europe during our individual meetings last week, we would like the Secretariat and the Committee to adjourn the consideration of my case in the forthcoming meeting of 5-7 June 2018 so that I have the opportunity to set out my views regarding the individual measures of my case.

I would be grateful if this matter was brought to the attention of the Members of the Committee of Ministers, prior to their forthcoming meeting 5-7 June 2018 pursuant to Rule 9 of its Rules for the Supervision of the Execution of Judgments.
