



To reinforce the working relation with CoE organs, institution and other external institutions and external experts.

Contribution of the Conference of INGOs to steering committees, committees of the parties PACE commissions Our recent online survey: 16/35 responses were received from our representatives on intergovernmental steering committees and other bodies.

In short, it shows that:

- 1- While there are examples of important contributions to the decisions of the Steering Committees, the reality of these contributions to standard setting is considered limited
- 2- Concerning the tasks entrusted to the representatives of the INGOs, almost half of the answers are "no" or "not yet";
- 3- Obstacles are identified which limit the contribution of INGOs to the work of the Steering Committees, a quarter of the replies state that they have not encountered any obstacle.
- 4- The inability to influence the agenda of the Steering Committees is assessed at 81%.

In summary, there is space for improvement.


