I. Introduction

The 5th plenary meeting of the CAHENF in Strasbourg from 16 to 18 October 2018 was chaired and opened by Ms Maria-Andriani Kostopoulou (Greece). The agenda and the list of participants are appended to the list of decisions.

II. Decisions

The CAHENF:

Agenda item 2: Adoption of the agenda and order of business

- adopted the draft agenda and order of business, as it appears in document CAHENF(2018)OJ2rev2;

Agenda item 3: Information by the Chair, Vice-Chair and Secretariat

- welcomed the update by the Chair and Vice-Chair of the CAHENF and the Secretariat;
- heard the update by the Chair on the reflections and outcome of the Meeting of Chairs of intergovernmental committees and the feedback on the evaluation of the CAHENF and other CoE committees by DIO;
- took note of the decision of the Committee of Ministers mainstreaming the area of the rights of persons with disability in CAHENF's Terms of reference;
- heard information provided by the Secretariat concerning the election process and on the review of working methods and proposals for appointment of rapporteur;

Agenda item 4: Implementation of the Council of Europe Strategy for the Rights of the Child (2016-2021)

- noted with great interest the state of progress, recent developments and challenges in member and observer states as well as the information provided by civil society representatives on the implementation of the priority areas covered by the Strategy;
- invited member states who have not yet sent their updates to do so within one week from the meeting;
- took note of the updated Action Plan for the CAHENF, as set in document CAHENF(2018)11, and requested the Secretariat to ensure that it is kept up to date on a regular basis;

Agenda item 5: CAHENF's ongoing work

5.1 Elaboration of guidelines

- took note of the report of the 4th meeting of the CAHENF-Safeguards, as it appears in document CAHENF-Safeguards(2018)PV2;
- discussed and unanimously approved the draft *Recommendation of the Committee of Ministers to Member States on guiding principles and guidelines for an effective guardianship for unaccompanied and separated children in migration;*
- instructed the Secretariat to proceed with the finalization of the draft text (including any last editorial corrections) and communicate the text to the Committee of Ministers for consideration and adoption;
- requested the Secretariat, in co-operation with the consultant, to elaborate further the draft explanatory memorandum to the draft recommendation, and submit it for discussion to the CAHENF-Safeguards, before circulating it for a last rounds of comments to all members;

- decided to entrust the Secretariat and the CAHENF Bureau to finalise the draft explanatory memorandum in the light of comments and submit it for adoption through an online procedure;
- agreed to provide further instructions and comments on the outstanding questions and revised text of the draft guidelines on age assessment by 9 November 2018;

5.2 Review of Recommendation CM/Rec(2007)9 of the Committee of Ministers to member states on life projects for unaccompanied migrant minor: progress and workplan

- took note of the update by the Secretariat of the state of progress of the review of the implementation of Recommendation CM/Rec(2007)9 of the Committee of Ministers to member states on life projects for unaccompanied migrant minors and the budgetary constraints for completing this review in 2018;
- invited member states to contribute to the survey and agreed to extend the deadline for submissions of responses to 31 October 2018;

5.3 Implementation of standards on the protection of children from violence in Member states: update on CAHENF-VAC's work and workplan

- took note of the information contained in the report of the 2nd meeting of the CAHENF-VAC held on 18-19 September 2018;
- heard an update on the work carried out by the CAHENF-VAC and took note of the updated roadmap and timelines, as well as expected contributions from member states, as they appear in documents CAHENF-VAC(2018)PV2 and CAHENF-VAC(2018)05rev;
- took note of the state of progress of the survey to be led in October/November 2018 on the responses by member States to violence against children, for which the deadline for reply will be 23 November 2018;

5.4 Implementation of existing standards and tools

Children's rights in the digital environment

- heard an update on the work undertaken regarding Recommendation CM/Rec(2018)7 of the Committee of Ministers to member States on Guidelines to respect, protect and fulfil the rights of the child in the digital environment and the elaboration of an Implementation Guide by the secretariat in collaboration with a group of consultants;
- agreed to provide further orientations through written contributions by 5 November 2018, and to seek out volunteers to act as reviewers of the upcoming draft Implementation Guide in 2019;

Child Participation Assessment Tool (CPAT)

- heard with great interest the oral update provided by the Secretariat and Bulgaria on past events and the upcoming work on the implementation of the Child Participation Assessment Tool (CPAT);

5.5 Support in strengthening child friendly services, in particular access, social and health services

- heard with great interest the presentations by Dr Martin Weber, Programme Manager for Child and Adolescent Health at the WHO Regional Office for Europe, Ms Polina Atanasova, Coordinator for the European Network of Ombudspersons for Children (ENOC) and Mr Paul Gilligan, Clinical Psychologist and Chief Executive of St. Patrick's Mental Health Services and Adjunct Assistant Professor in Trinity College Dublin, and exchanged views on several issues in the area of the rights of the child and mental health;
- instructed the Bureau to report back to the Committee with suggestions for further action, taking into account the identified needs and the CAHENF's mandate;

Agenda item 6: CAHENF opinions for the Committee of Ministers

- invited the Secretariat to provide further updates on the response by the Committee of Ministers to PACE Recommendation (2137)2018 on "International obligations of Council of Europe member states: to protect life at sea";

- instructed the Bureau to prepare draft opinions as may be requested by the Committee of Ministers for their approval through electronic communication or at the next plenaries.

Agenda item 7: CAHENF priorities and work plan in 2018-2019

7.1 Preparation of the Mid-term evaluation of the Strategy for the Rights of the Child: process and High-Level Conference (June 2019)

- noted the information provided by the Secretariat on the organisation of the mid-term evaluation of the Strategy and endorsed the concept note (CAHENF(2018)09rev);
- noted the state of play regarding the preparation of the High-Level Conference and invited the Secretariat to communicate as soon as possible the dates and venue of the event and to prepare the concept note and programme of the High-Level Conference in co-operation with the Bureau of the CAHENF;
- agreed to provide replies to the draft questionnaire for the mid-term evaluation process as soon as possible and no later than 7 January 2019;
- noted also the information provided on the child participation process to be launched in October 2018 in the framework of the mid-term evaluation of the Strategy and the call and encouragement of the Secretariat to involve children in the evaluation of the Strategy and in the High-Level Conference itself, with the support of Eurochild
- agreed to communicate as soon as possible to the Secretariat the name of the Minister(s) to be invited to the High-Level Conference;

7.2 Draft work plan for 2018- 2019

- welcomed the format proposed for the CAHENF's work plan (CAHENF(2018)12) and endorsed the text as modified;

7.3 Participation of CAHENF representatives in other events (2018-2019)

- took note of the information provided by the Chair on participation in other events and confirmed its representatives to other events as set out in document CAHENF(2018)3 REV2;

Agenda item 8: Relevant Council of Europe actions and activities and possible future contributions or follow-up by the CAHENF

8.1 Council of Europe Action Plan on protecting migrant and refugee children (2017-2019)

- held an exchange with Ambassador Tomas Bocek, Special Representative of the Secretary General on Migration and Refugees following his oral update on the mid-term evaluation of the implementation of the Action Plan on migrant and refugee children and took note of his invitation to focus on identifying good practices on how to ensure that the principle of the best interest of the child is upheld in the context of age assessment processes;
- took note of upcoming events organised by the Children's Rights Division to follow-up on the

country fact-finding visits of the Special Representative of the Secretary General on Migration and Refugees (Strasbourg, 4-5 December 2018) and the call to implement age assessment consultation workshops with unaccompanied and separated children to support the CAHENF's work;

8.2 Council of Europe Counter-Terrorism Strategy (2018-2022)

- took note that the planned event in the framework of the Council of Europe Counter-Terrorism Strategy (2018-2022) is now scheduled in 2020 and decided to resume discussion on its possible contribution at the next meeting(s);

Agenda item 9: Election of the Chair and Vice-Chair

- re-elected Ms Maria-Andriani Kostopoulou (Greece) as Chairperson and Ms Satu Sistonen (Finland) as Vice-chairperson for a new mandate of one year from 2018-2019;
