

- A 20-day period is automatically applicable in order for the parties to submit an appeal to the National Anti-Doping Appeals Panel NADAP (an independent panel within the NADO).
- The members of the NADAP confirm that they do not have a conflict of interest and can hear the case.
- A request for submission is sent by the NADAP to the party (not the appellant) for a reply to the appeal.
- A date of hearing is communicated by the NADAP to all parties.
- Decision following a hearing within 21 days.
