Describe, upload documents or add the link to the relevant content In Romania, the ADRV appeals are regulated via Law no. 227/2006 and more specifically provided for in the Regulations for the organization and functioning of the Appeal Panel.

The Appeal Panel consists of 7 voting members appointed by: the academia (2), the Romanian Olympic and Sports Committee (1) and

the General Secretariat of the Government (4) for a 2-year mandate which can be renewed.

In consideration of the T-DO/Rec (2017) 01 (namely section 2c) "procedural fees should not prevent a person from accessing to the hearing") the fee to file an appeal has been cut down via decision published in the Official Journal of Romania.

At the present time, the Regulations for both panels (Hearing Panel and Appeal Panel) are being re-drafted in outcome to the changes introduced by the 2021 version of the WADA Code. As such, in consideration of the institutional independence requirement established for the appeal panels, the Appeal Panel will be given a new regulatory framework.
