## TENDER FILE / TERMS OF REFERENCE (Competitive bidding procedure / One-off contract)

# Purchase of consultancy services for the regional assessment of corruption risks in public procurement processes and practices in the Western Balkans and Turkey



The Council of Europe (CoE) through the Economic Crime and Cooperation Division (ECCD) is currently implementing the Regional Action against Economic Crime in Western Balkans and Turkey (HFII-AEC-REG) in the framework the CoE/EU Horizontal Facility for Western Balkans and Turkey - Phase II. In that context, it is looking for a Provider for the provision of consultancy services in the field of public procurement (See Section A of the Act of Engagement).

#### A. TENDER RULES

This tender procedure is a competitive bidding procedure. In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe¹, the Organisation shall invite to tender at least three potential providers for any purchase between €2,000 (or €5,000 for intellectual services) and €55,000 tax exclusive.

This specific tender procedure aims at concluding a **one-off contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 120 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be either a natural person, or a duly registered company under sole proprietorship of a natural person, or equivalent, provided that the signatory of the Act of Engagement is individually liable for all obligations undertaken by the entity and is the owner of the moral rights in any creations of the entity. If contracted by the Council of Europe, the signatory of the Act of Engagement shall provide the deliverables personally, in accordance with the terms as provided in the present Tender File and Act of Engagement.

Tenders shall be submitted by email only (with attachments) to the email address indicated in the table below, with the following reference in subject: HFII-AEC-REG/TF Consultancy services-Public procurement. Tenders addressed to another email address will be rejected.

#### B. EXPECTED DELIVERABLES

The Regional Action against Economic Crime in Western Balkans and Turkey is part of the European Union/Council of Europe Horizontal Facility for the Western Balkans and Turkey – Phase II (HF II), a cooperation initiative of the European Union and Council of Europe for South East Europe. Horizontal Facility Phase II, is implemented from May 2019 to May 2022 and continues to build on the Statement of Intent signed on 1 April 2014 by the Secretary General of the Council of Europe and the European Union Commissioner for Enlargement and European Neighbourhood Policy, in which both Organisations agreed to further strengthen their co-operation in key areas of joint interest.

The Horizontal Facility includes Albania, Bosnia and Herzegovina, Kosovo\*, Montenegro, North Macedonia, Serbia and Turkey. Beneficiaries and counterparts include governmental bodies at all levels, notably specialised structures within the Ministries of Justice, Interior and Finance; anti-corruption bodies; Judicial and Prosecutorial Services, supervisory bodies; Financial Intelligence Units (FIUs), and representatives of civil society.

The Action aims at fostering a uniform approach to the implementation of relevant GRECO and MONEYVAL standards, as well as supporting cooperation and coordination on cross-border aspects of the fight against economic crime in the beneficiary countries.

One of the Action's outcome aims at enhancing public procurement framework of participating jurisdictions and involves:

- i) conducting a regional assessment of corruption risks in public procurement processes and practices with recommendations for improvement; and
- ii) developing guidelines on good practices related to contract execution and oversight.

The expected deliverables are described in **Section A of the Act of Engagement** (See attached).

#### C. FEES

All tenderers are invited to fill in the **table of fees** as reproduced in **Section A of the Act of Engagement**.

Tenderers subject to VAT shall also send a quote (Pro Forma invoice) on their letterhead including:

- the Service Provider's name and address;
- its VAT number;
- the full list of services;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive.

#### D. ASSESSMENT

Exclusion criteria and absence of conflict of interests

(by signing the Act of Engagement,<sup>2</sup> you declare on your honour not being in any of the below situations) Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;

<sup>-</sup> A certificate issued by the competent authority of the country of incorporation indicating that the fourth criterion is met;

<sup>-</sup> For legal persons, an extract from the companies register or other official document proving ownership and control of the Tenderer;

<sup>-</sup> For natural persons (including owners and executive officers of legal persons), a scanned copy of a valid photographic proof of identity (e.g. passport).

- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are or are likely to be in a situation of conflict of interests;
- are or if their owner(s) or executive officer(s), in the case of legal persons, are included in the lists of persons or entities subject to restrictive measures applied by the European Union (available at <a href="https://www.sanctionsmap.eu">www.sanctionsmap.eu</a>).

#### Eligibility criteria

- University degree in law, political or social sciences or related field;
- At least 5 years of experience in the field anti-corruption and good governance, and at least 2 years in the area of public procurement at international and/or national level
- Excellent knowledge of applicable international standards and good practices;
- Experience related to the assessment of risks in the field of anti-corruption and good governance and in particular in the area of public procurement;
- Excellent written and spoken English; and
- Previous experience in the geographical area would be considered a strong advantage.

#### Award criteria

- Quality of the offer (70%), including:
  - demonstrated professional experience in the public procurement area;
- Financial offer (30%).

Multiple tendering is not authorised.

#### E. NEGOTIATIONS

The Council reserves the right to hold negotiations with the bidders in accordance with Article 20 of Rule 1395.

#### F. DOCUMENTS TO BE PROVIDED

Tenderers are invited to submit:

- A completed and signed copy of the Act of Engagement<sup>3</sup> (See attached)
- For tenderers subject to VAT <u>only</u>: **a quote, describing their financial offer**, in line with the requirements of section C of the Tender File (see above);
- A list of all owners and executive officers, for legal persons only;
- The latest CV;
- Portfolio of previous similar engagements
- At least one example of previous work on the same or similar topic.

At the time a specific assignment is ordered from a tenderer (natural person) belonging to the category of civil servant or other public administration staff under the second phase of the Horizontal Facility, and following on the entry into force of Addendum 3 to the Horizontal Facility II contract with the European Union, the respective tenderer will be required to submit a written confirmation by his/her employer that secondary activities are allowed by national/local legislation and that the employer authorises the tenderer to carry out the object of this tender procedure as a secondary activity. In the absence of such a confirmation, the Council of Europe reserves the right to withdraw the order.

Alternatively, at the time a specific assignment is ordered from a tenderer (legal person) assigning the production of the expected deliverables to an individual belonging to the category of civil servant or other public administration staff under the second phase of the Horizontal Facility, and following on the entry into force of Addendum 3 to the Horizontal Facility II contract with the European Union, the respective tenderer will be required to verify and provide the Council of Europe with the necessary supporting documents confirming that this individual submitted a written confirmation by his/her employer that secondary activities are allowed by national/local legislation and that the employer authorises the individual to carry out the object of this tender procedure as a secondary activity. In the absence of such a confirmation, the Council of Europe reserves the right to withdraw the order.

### All documents shall be submitted in English or French, failure to do so will result in the exclusion of the tender.

The scanned Act of Engagement may be sent page by page (attached to a single email) or as a compiled document, although a compiled document would be preferred. If any of the documents listed above are missing, the Council of Europe reserves the right to reject the tender.

The Council reserves the right to reject a tender if the scanned documents <u>are of such a quality</u> that the documents cannot be read once printed.
