OBJECTIVES

The main objectives of the 11th Meeting of the <u>COE-FRA-ENNHRI-EQUINET Collaborative Platform on</u> <u>Social and Economic Rights</u> are:

- To present the study "Against Ageism and Towards Active Social Citizenship for Older Persons. The Current Use and Future Potential of the European Social Charter" and consider its main thesis about the legacy of ageism in Europe and the need to use the European Social Charter to help roll it back;
- Through the study, to reflect on the adequacy and potential of the main European human rights standards for the advancement of the human rights of older persons and in particular the European Social Charter and the EU Charter for Fundamental Rights;
- To examine the recommendations set out in the study and discuss possible ways to advance and implement them at national level;
- To examine the role of National Human Rights Institutions and National Equality Bodies in advancing and protecting the rights of older persons at both the national and European level;
- To reflect on the central role of civil society in advocating against ageism and in utilising all available legal means including the European Social Charter to do so.

BACKROUND

The idea for this study came from the COE-FRA-ENNHRI-EQUINET Collaborative Platform on Social and Economic Rights in 2020 and was financially supported by the Council of Europe, Department of the European Social Charter.

In 2020, the COVID-19 pandemic and the measures it provoked raised an unprecedented collective challenge to the fundamental human rights of everyone. Older people were severely affected,

especially those living in institutional settings or with underlying health conditions. The COVID-19 pandemic not only highlighted the vulnerable situation of older persons, it also witnessed cases of ageism and human rights violations against older persons, particularly with regard to the rationing of health. The pandemic has made the institutionalisation of older persons not just a human rights issue but also a public health issue. Long-term care must mean more than institutionalisation. This is why, international organisations have been consistently promoting a rights-based approach to tackling the pandemic. And this approach has been heavily relied on through the whole study.

Therefore, the meeting aims to bring together national and international human rights players to discuss, on the basis of the published study, ways of improving the situation of older persons across Europe; to see how different international human rights standards can be optimised to uphold the rights of older persons and to inspire national policies ensuring respect for dignity, equality and non-discrimination.

The study also analyses the role of governments which represent the "power", civil society – the "voice" of older persons and National Human Rights Institutions/Equality Bodies – the "ideas" and whether and how the European Social Charter can equip all of them to interact effectively in moving Europe away from the ageist laws and policies of the past.

More importantly, the study lays out a vision of how the Charter can be optimised in the future as Europe struggles to eliminate ageist laws and policies. Therefore, the meeting aims to examine the suggested recommendations and explore concrete ways of their implementation at national level.

PARTICIPANTS

The event is designed to bring together representatives of the Council of Europe, European Union and United Nations institutions and agencies, national human rights institutions, national equality bodies and civil society for a discussion on optimising the use of the Social Charter to combat ageism and strengthen the protection of the rights of older persons.

The meeting will be held via the Council of Europe online platform KUDO in English and French with simultaneous interpretation.
