# ONLINE CONFEERENCE FOR LAWYERS "NEW RULES OF CIVIL PROCEDURE: A STEP FORWARD"

# CONCEPT

Today Cyprus is undertaking the ambitious reform process with a view to improving the court system and strengthening the efficiency of justice. An important step in the ongoing reform - revision of the Rules of Civil Procedure - is facilitated under a Joint project of the COE and EU in collaboration with the Supreme Court.

Successful progress in the integration of the new Rules into the Cypriot civil law and procedure, which will undergo a serious reformation for the first time during the last 60 years, is of paramount importance as it is expected to provide ground for improvement of the efficiency of justice and to contribute to an investment-friendly environment in Cyprus.

While the most difficult and demanding part – the drafting of the Rules and Forms – is over, the next challenging step – adoption and implementation of the new Rules – is ahead.

At the Conference the Draft Rules will be presented and the philosophy behind them will be explained for better understanding of particular provisions and changes in the civil procedure. In anticipation of the collection of the comments to the Draft Rules from the legal community, such explanations are expected to contribute to the process of the preparation of the comments. Also, comparison of the process of the change of Rules in other Common Law jurisdictions could be a valuable contribution to the understanding of the novelties in the Draft Rules and the philosophy behind them.

The challenges, questions and possible solutions linked to the application of new procedural rules in various jurisdictions will be discussed at the Conference. The discussions will be dedicated to the exchange of experience of practicing lawyers and judges from the UK and Ireland faced with such changes. The participants will be presented with the new Rules and the logic behind them, which will be followed by discussions about the practical benefits for lawyers and other stakeholders.
