




CLOSING EVENT OF THE COUNCIL OF EUROPE PROJECT "ENHANCED SOCIAL PROTECTION IN UKRAINE"



BACKGROUND

- Social rights are core European values enshrined in a number of formal commitments undertaken by the Council of Europe member states, including Ukraine. These commitments include the European Social Charter (revised). Respect for and the promotion of social rights is essential in attaining sustainable democracy in Ukraine. Ukraine ratified the European Social Charter (revised) (ESC/Charter) on 21 December 2006, accepting 76 of its 98 paragraphs. It has yet to ratify the Additional Protocol providing for a system of collective complaints.
- During 2019-2024, the Council of Europe implemented several co-operation projects aimed at promoting social human rights in Ukraine, which contributed to the development and implementation of new policy documents in line with the ESC standards and requirements, and initiation of important reforms in the areas of social services, labour rights, rights of people with disabilities.

ABOUT PROJECT

- The Council of Europe project "Enhanced social protection in Ukraine" (hereinafter the project) launched in 2023, covers the period of 01 January 2023 31 December 2024 within the framework of the Council of Europe Action Plan for Ukraine "Resiliency, Recovery and Reconstruction" for 2023-2026¹. Its aim was to attain that people from vulnerable groups, including war-affected population in Ukraine, enjoy improved level of social rights and social protection. To achieve this, a combination of targeted activities was envisaged in two directions. First, the policy and legislative framework on social rights were aligned with the European standards, more particularly the ESC and case law of the European Committee of Social Rights. Second, national and regional authorities were encouraged and capacitated to promote the social rights of persons from vulnerable groups and the general public, in particular addressing the issue of non-take up of social rights.
- The need to protect social human rights has become even more pressing since the beginning of the Russia's war of aggression against Ukraine. It has resulted in forced displacement of millions of people (both internally and abroad), the loss of homes, property, employment, and means of livelihood by hundreds of thousands of people, damage to physical and psychological health, and many other adverse effects. The project aimed at further supporting the Ukrainian authorities in addressing the current challenges posed by the war in the area of social rights, implementing the reforms already embarked on in the above-mentioned areas, in line with the requirements of the ESC and relevant European standards. The latter process has become even more important given the opening of EU accession negotiations with Ukraine in 2023.

OBJECTIVE OF THE CLOSING EVENT

The closing event of the Council of Europe project "Enhanced social protection in Ukraine" aims at presenting the results achieved over the past two years of the project's implementation. It will also reaffirm the partners' commitment to continuing the co-operation with the Council of Europe in the area of social rights protection, as part of the Council of Europe Action Plan for Ukraine "Resilience, recovery, reconstruction" for 2023-2026.
