"Crimes against Human Dignity: Interaction of International and National Remedies"

organised by the Council of Europe in co-operation with the Russian Federal Bar Association and the International Commission of Jurists

Moscow, 28 March 2019

Crimes against human dignity are egregious violations of human rights which require robust remedies in both national and international law.

Such violations may primarily affect physical and moral integrity of a person, notably through illtreatment, domestic violence, trafficking in human beings and other forms of modern slavery. The core provisions of the European Convention on Human Rights and the related case-law of the European Court of Human Rights are of particular relevance in combatting these phenomena.

The Conference will address the relevant national and international remedies against such crimes and serve for exchange of good legal practices in that regard.

The practicing lawyers from different countries will share their experience regarding the identification, qualification and assessment of such violations, the assessment of evidence in criminal proceedings, and the work with victims.

The Conference is expected to raise awareness about accessibility and enforceability of remedies in respect of such crimes and to spread the practices of successful national and international litigation in this area.

After a general introductory session thematic sessions will be held to highlight the specifics of legal work at different procedural stages to prevent, combat and remedy such violations.
