### International and national perspective and challenges in dealing with ill treatment allegations concerning disadvantaged groups

#### Fact Sheet

The aim of the International Conference is to raise awareness about relevant case-law of the European Court of Human Rights (ECtHR) in relation to the effective investigation of allegations of ill-treatment of disadvantaged groups (LGBTI, migrants, Roma, religious and ethnic minorities). It will have comparative focus, but will also refer to identified problems in Turkey through the ECtHR case-law and measures employed at national level to execute latter's judgments. Furthermore, it will serve to discuss about shortcomings and challenges in national procedures and mechanisms and to incite discussions for proposing solutions. Finally, the conference will tackle the issue of the increased domestic violence and raise awareness of having more preventive and combating measures to reduce and adequately punish the perpetrators. In that context GREVIO findings on Turkey will be presented.

The conference time will be devoted to presentations and discussions in three discussion panels, each addressing a particular issue:

- Dissemination of the relevant case law of the European Court of Human Rights (ECtHR) and national jurisprudence in relation to in relation to effective investigations of allegations of ill-treatment of disadvantaged and vulnerable groups; Comparative and Turkish Context;
- 2. Challenges in execution of judgments of the ECtHR; Good practices and shortcomings in that context;
- 3. Impact on legal and procedural reforms related to issues of migrants and foreigners;
- 4. Challenges related to prevention and combating violence against women: International standards and Turkish perspectives, including findings of GREVIO report on Turkey.
