## Concept Note

### Protection of Journalists- a multistakeholder dialogue

**Objective:** In the wake of increasing threats, violence, and challenges faced by journalists worldwide, the thematic conference on the Protection of Journalists serves as a critical platform for a comprehensive dialogue and strategic planning. The objective of this conference is rooted in the Council of Europe's Recommendation [CM/Rec\(2016\)4](#) on the Protection of Journalism and Safety of Journalists, and its four pillars: Prevention, Protection, Prosecution, and Promotion. Particularly, it marks the first of the series of 4 major events throughout the Council of Europe "Journalists Matter" [Campaign on the Safety of Journalists](#), focusing on the Protection pillar, also in line with the [European Commission's Recommendation on the protection, safety and empowerment of journalists](#).

Discussions will address the main target groups of the Campaign: public authorities, including the judiciary, law enforcement, civil society, journalists' and media organizations, and international organisations. Council of Europe main bodies' representatives, including Parliamentary Assembly, Congress of local and regional authorities, Platform to promote the protection of journalism and safety of journalists, will also be present.

The event will highlight the democratic function of journalists in various contexts, raising awareness of the important role they perform during crises, elections, demonstrations, and conflict zones.

The participants will delve into the legislative frameworks addressing violence against journalists and assess/discuss the efficacy of existing laws. They will explore ways to improve practical protection measures, including by law enforcement bodies, partnerships and/or memorandums of cooperation that are likely to help better protecting journalists' safety, as well as the importance of procedural guarantees in cases of deprivation of liberty, emphasizing the right to legal representation, medical assistance etc.

Discussions will look into measures that media organizations themselves, but also media owners, are expected to take to ensure that their journalists are prepared and protected against pressure, intimidation and attacks. The role of the civil society in raising public awareness of the role of journalists and the importance of their protection will also be tackled.

Recognising the specific dangers faced by female journalists, the conference will emphasize gender-specific approaches in protective measures. Finally, the conference will discuss best existing initiatives and practices in member states, including protocols of collaboration between journalists and relevant stakeholders that have a role in journalists' safety.
