"Protection of property: ECtHR and national case-law in the Western Balkans"

9 December 2020

Background

The **objective** of the online conference is to provide a platform for a discussion among the stakeholders in the countries of the Western Balkans on the challenges related to the enjoyment of the right to property protected under Article 1 Protocol 1 of the European Convention on Human Rights. While the range of issues faced by different jurisdictions in the region varies from restitution of nationalised property to non-enforcement of judicial decisions to matters related to receiving pensions, the European Court of Human Rights in its case law established well-defined approaches on what the right to property includes, and what remedies should be available in order to secure it.

Due to time constraints, the discussion will focus on several areas, with the possibility to discuss other related issues during the discussion sessions. Speakers will include lawyers from the ECtHR Registry, renowned experts in the subject matter and legal practitioners from the countries of the Region.

The working language will be English with simultaneous interpretation into Albanian, Macedonian and Bosnian/Croatian/ Montenegrin/Serbian.
