

Round table on Gender equality and open government for stronger local democracy

14 – 15 March 2019 Venue: Hotel Aloft, 17 Esplanadna St, Kyiv, Ukraine

CONTEXT

The Congress of Local and Regional Authorities of the Council of Europe (the Congress) is organising jointly with the Association of Ukrainian Cities (AUC) a round table to streamline gender into open local government and thereby advance gender equality and local self-government through increased transparency, participation, accountability, and government responsiveness.

Open government has the potential to accelerate gender equality and drive change through gender-sensitive policymaking. Local authorities have a key role in the implementation of the Council of Europe Gender Equality Strategy 2018-2023 and Ukraine's commitments to the OGP 4th National Action Plan and the UN Sustainable Development Goals 5 (Gender Equality) and 16 (Peace, justice and strong institutions), especially to ensure equal opportunities for representation at all levels of decision-making in political and public life.

The round table will gather together local elected representatives and public officials from all regions of Ukraine, members of the Government of Ukraine and other national stakeholders, as well as representatives of national associations of local authorities from Ukraine and other European countries to share experiences and good practices to incorporate a gender perspective into open government in Ukraine.

The round table is organised as part of the Open Government Week (11-17 March 2019) and within the project "Strengthening democracy and building trust at local level in Ukraine", which aims to improve the quality of local democracy in Ukraine by strengthening institutional frameworks and by supporting local authorities and their national associations in their efforts to promote ethical decision-making and more citizen-oriented, inclusive and transparent local governance. The project is implemented by the Congress within the Council of Europe Action Plan for Ukraine 2018-2021.
