# **5.2.** Proposal for amendment: Downlisting of the wolf (*Canis lupus*) from Appendix II to Appendix III of the Convention

The Chair will recall that, in 2018, Switzerland proposed an amendment to the Appendices of the Convention in accordance with Article 17, paragraph 1, of the Bern Convention, to downgrade the wolf (*canis lupus*) from Appendix II (strictly protected fauna species) to Appendix III (protected fauna species). The 38<sup>th</sup> Standing Committee did not decide on the proposed amendment as Contracting Parties were not ready to take a position. Following a renewal of the request by Switzerland on 5 April 2022 and pursuant to Article 17, paragraph 2, of the Convention, the Standing Committee will be invited to re-examine the proposed amendment of the Appendices II and III.

The national delegation of Switzerland will be invited to present the proposal for amendment.

The Chair of the IUCN Large Carnivore Initiative for Europe (LCIE) will inform Parties of the conservation status of the wolf at pan-European level.

# **DECISION**: The Standing Committee is invited to:

- take note of the pan-European assessment of the conservation status of the wolf prepared by the LCIE;
