#### **GENERAL INFORMATION ON MIGRATION**



### **MAIN FIGURES AND TRENDS**

With regard to immigration arriving in Andorra, it should be noted that the tendency that is being observed in the country is a decrease in the number of immigrants who are nationals of the European Union or the European Economic Area to the detriment of a marked increase in immigrants of non-EU nationalities, with a predominance of nationals of South American countries.

The only details that are available are the nationalities of the immigrants.

A table with the initial authorisations granted this year (until October 25, 2023) is attached below<sup>1</sup>.

#### **MIGRATORY ROUTES**

The Immigration Department does not have data on the countries of origin, transit or destination of migrants entering or leaving the country.

A table with the different nationalities of the immigrant population in Andorra, taking into account the authorisations in force on October 25, 2023 is attached below<sup>2</sup>. It can be seen that we have a total of 52.582 immigrants in the Principality of Andorra of 124 different nationalities.

It should be noted that the Principality of Andorra is not located on any migratory route.

### **INSTITUTIONAL ORGANISATION**

The Police Department of Andorra organisationally depends on the Ministry of Justice and Interior, having among others, competencies in immigration matters, a mission delegated to the Borders and Foreigners Unit which is organisationally subdivided into three groups: Borders Group, Foreigners Group and Anti-Fraud Group.

The Borders and Foreigners Unit is entrusted with the following missions in immigration matters:

- a) To control the entry of foreigners into the Principality of Andorra and the immigration status of foreigners who are in the country.
- b) To process all applications, instruct files on immigration matters related to security and public order and the effectiveness of residence, and in the latter case, conduct residence surveys or other investigations aimed at ensuring compliance with immigration matters and adequacy to the legally provided assumptions.
- c) To process and instruct all files relating to authorisations for residence without work.
- d) To adopt administrative police measures of expulsion or denial of entry, in the cases provided for and following the procedure set in the current Immigration Law.
- e) To prepare studies and reports to facilitate the determination of future immigration quotas.
- f) To exercise the powers which, in accordance with current regulations and in a complementary manner with the Immigration Department, are typical of the Immigration Service.

### **LEGISLATIVE FRAMEWORK**

Our criminal code punishes the different kinds of migrant smuggling in its articles 121 bis (organs trafficking), 134 bis (sexual exploitation) and 252 (labor exploitation).



### JUDICIAL FRAMEWORK

In our judicial system, migrant smuggling is not investigated in any special court. The only way to force the investigation of a case of migrant smuggling by a specialised court is when the crime is committed by organised crime.

The procedural law applying to both cases is the same, the only thing that changed is the distribution criterion. When besides of the migrant smuggling there exist one type of crime reserved to the specialized court, the case has to be allocated to a specialized judge.

The role of the prosecutor is the same as in any other procedures, to prosecute the public accusation.

## **INTERNATIONAL COOPERATION**

The International Police Cooperation Office, reporting to the Directorate of the Police of Andorra, exchanges information with INTERPOL, embassy law enforcement liaisons, and information sharing networks to combat migrant smuggling bilaterally and multilaterally. This cooperation occurs through INTERPOL, bilateral agreements, regional networks, and letters rogatory.

Andorra values ongoing collaboration with partners to share timely, actionable intelligence disrupting organised crime while upholding human rights. With mutual respect for sovereignty, Andorra seeks to expand authorised intelligence sharing related to migrant smuggling and human trafficking, contributing to collective security. Andorra remains committed to enhancing international police cooperation against migrant smuggling through existing mechanisms and new partnerships. The Police Department is currently working on an agreement with Europol to be implemented in the International Police Cooperation Office, which will cover the European region and facilitate joint police operations with other Europol members in this fight.

In addition, the Principality of Andorra is a State Party to numerous conventions on judicial cooperation in criminal matters, as well as to international organisations such as IberRed, which has specific contact points depending on the subject, as well as the contact points provided for in the United Nations Convention against Transnational Organized Crime.

Andorra has signed a number of different international conventions, some covering very specific subjects. Among these, one of the most widely used conventions for international cooperation in general is through the Council of Europe's 1959 European Convention on Mutual Assistance in Criminal Matters.



## **RELEVANT CASES**

#### Case #1

Date of the events: June 2018

The owner of a business hired three preople from South America by imposing illegal and abusive conditions upon their arrival. These people traveled from their country to Andorra seduced by some announced good work conditions which in the end were no real. Investigation is still ongoing.

#### ❖ Case #2

Date of the events: /

Three people who worked as administrative managers created fake legal entities and they inscribed several foreign people as members of these entities to get them legal residence in Andorra although they lived outside the country. In some cases, the investigated people forced some of these foreign people to prostitute themselves as payment for the services.

They were prosecuted for migrant smuggling for the prurpose of work exploitation, money laundering, fake enterprises and document forgery. Investigation is still ongoing.

#### ❖ Case #3

Date of the events: May 2021

Two people rented an apartment in Andorra to start an illegal prostitution business. They offered a prostitution job throught the internet and a foreign woman contacted them to apply for the job. These two people rented an apartment to have a place for the sexual activity and they offered the services of this foreign woman throught the internet, giving the contact number of one of these two people.

Several clients contacted these people to contract the announced sexual services and the two people forced the woman to do these services even when she was exhausted and they took all the money that the clients payed for the services.

In addition, the two people hit the victim.

They were prosecuted for, among others, migrant smuggling for the prurpose of sexual exploitation and they were acquitted of this crime, but they were condemned for others crimes such as pimping.
