- a. the draft recommendation on the protection of the rights and best interests of the child in parental separation proceedings as well as the work on migration and access to nationality for stateless persons (in particular regarding children) take into account the Strategy for the Rights of the Child and both contribute to UNSDG 16;
- b. the guide on mainstreaming gender in public and private law reform processes takes into account the Gender Equality Strategy and contributes to UNSDGs 5 and 16;
- the ongoing work on a draft convention for the protection of the profession of lawyer takes into account the Gender Equality Strategy and contributes to UNSDGs 5 and 16;
- d. the updated Handbook "The Administration and you" contributes to UNSDG 16;
- e. the follow-up action planned by the CDCJ to give effect to its report on the implementation of the Council of Europe Plan of Action on Strengthening Judicial Independence and Impartiality contributes to UNSDG 16.

¹ The term "Roma and Travellers" is used at the Council of Europe to encompass the wide diversity of the groups covered by the work of the Council of Europe in this field: on the one hand a) Roma, Sinti/Manush, Calé, Kaale, Romanichals, Boyash/Rudari; b) Balkan Egyptians (Egyptians and Ashkali); c) Eastern groups (Dom, Lom and Abdal); and, on the other hand, groups such as Travellers, Yenish, and the populations designated under the administrative term "Gens du voyage", as well as persons who identify themselves as Gypsies. The present is an explanatory footnote, not a definition of Roma and/or Travellers.
