Since the area has both wetland and national park status, it is deemed appropriate to make a single plan under the name of Kuscenneti National Park Long Term Development Plan and Wetland Management Plan. The draft plan was approved by the Ministry Authority in November 2018. The activities defined in the plan will start to be implemented as of 2019.

2. Submit any development project regarding the lake, its shores and tributaries, or concerning agricultural or industrial facilities, to a rigorous environmental impact study, the conclusions of which should be communicated to the Council of Europe;

The water quality examination and control of Sigirci River is monitored by the Ministry of Environment and Urbanism.

In addition, "Manyas Lake Sub Basin Water Quality Action Plan (2016-2021)" has been studied by Meriç Albay, one of the lecturers of Aquaculture Department, Istanbul University.

The targets for precision protection in the park that have been defined the already approved plan and will start to be implemented carefully from 2019 onwards.

3. Regularly monitor the breeding bird population of the park, and carry out research on the dynamics of these populations particularly at Sigirci Delta and Kocacay Delta;

Bird population dynamics have been observed and recorded at 12 different points, especially Sigirci Delta and Kocaçay Delta.

In May 2018, a satellite transmitter has been mounted on two Dalmatian pelicans (*Pelecanus crispus*). One of the pelicans flew to Greece.

4. Continue efforts to control pollution caused by poultry and livestock farming and monitor continually the water quality of the lake and of the streams flowing into it.

There are no facilities within the boundaries of the National Park. All facilities in the buffer zone are permitted according to "Annex-2 of the Regulation on the Protection of Wetlands" and the operators are regularly inspected. Warning and penal sanctions are applied.

- 1. Increase the number of staff to meet the increased workload due to the park's enlargement;

In 2018, 5 people started to work in the national park as permanent workers who were employed with procurement of services through subcontractors from the village adjacent to the National Park. In addition, within the scope of the state project, İŞKUR (Turkish Employment Agency), 5 people were assigned to the National Park for 6 months (with a high visitor density period).

2. Ensure the natural fluctuations in the lake's water level, including spring flooding and the drying up of the shoreline in summer;

Monitoring of water level and water quality is done by DSI (General Directorate of State Water Affairs) and natural fluctuation is observed.

3. Set up a small wardening unit on the southern shore of the lake (in the Kocacay Delta area) to guarantee the protection of the area.

In the Kocaçay Delta section, the wardening unit has been defined in the already approved plan and will be interpreted and implemented after 2019.

- •1 vehicle has been allocated for use in the park.
- Bird observation tower was renovated and 1 telescope was installed for bird watching.
- Maintenance and reed coating of (58 pieces) Pelican nests were completed.
- Construction of Social facilities included 6 WC, 1 Disabled WC, 1 Lactation Room and 2 Prayer Room have been started in the National Park and will be completed in 2019.
- Preparation of a project for a major renovation of the Administration and Visitor Promotion Center.

There is no change in the boundary of the park.

- Recommendations for the use of the European Diploma of Protected Areas its logo as a result of the meeting held in March 2018 were included in the Regional Directorate programme for inclusion in the materials to be prepared in 2019.
