1. draw up and implement three-year action plans, within the framework of the management plan (2011-2031), and set up a monitoring mechanism based on performance and conservation indicators; In 2019, the Park began implementing of nature protection tasks for the years 2019-2021 (ordinance of the Minister of the Environment from 20.12.2018)

On the basis of this document, strict protection of forest ecosystems and alpine pastures was carried out on 70% of the area. Active protection was carried out on the remaining area, including grazing and mowing of meadows (about 2 thousand hectares) and rebuilding of coniferous monoculture (about 100 ha). An area of the Park was opened for tourists - in 2019, the Park was visited by 600,000 visitors. The Park conducted extensive ecological education for various social groups, in which about 24,000 people participated.

2. pursue the efforts to include the beech forests of the Bieszczady National Park on the World Natural Heritage list; aim to harmonise the management of the contiguous beech forests and upland meadows with the similar forests and meadows across the border in the Poloniny National Park (Slovak Republic); In 2019, efforts to include the most valuable fragments of beech forests, on the list of World Natural Heritage were resumed. In 2019, the serial entry was prepared and sent to the coordinating institution (E.C.O. Institute of Ecology in Austria) regarding updated materials on the objects planned for adding to the World Heritage List in the Bieszczady National Park. The planned deadline for submitting the application is January 2020.

3. manage and control visitor pressure; devise and implement with local stakeholders a sustainable tourism strategy and a prioritised action plan so that the infrastructure of facilities can be developed in line with conservation objectives of the area; In 2019, the Park continued the implementation of the project regarding the improvement of marked trails and the protection of the natural environment at tourist routes.  
 As part of this project, in this year following elements were built on the trails: 975 erosion control steps, 32 wooden benches, tape barriers - 1860 m; renewal of marking on hiking trails - 35 km, 160 stone steps, 250 m<sup>2</sup> of stone slabs, 24 drainage elements, 74 signposts, 22 wooden pillars and 45 guide poles and other the necessary elements were purchased.  
 The Park also carries out the contract for the reconstruction of the mountain shelter on Polonina Wetlińska.

4. strengthen co-operation between the management of the Bieszczady National Park and municipalities, with a view to forging a common vision and designing common objectives for regional planning and development, taking the biological and landscape interests, and sensitive nature of the site, into account; Representatives of the Park participated in meetings of local communities at the level of the Council of Municipalities and Poviats Councils. In turn, representatives of local governments participated in the meetings of the BNP Scientific Board.

5. develop further awareness-raising and educational activities on the role of biodiversity and ecosystem services targeting children and youths;

Over 5.1 thousand participants took part in permanent educational programs, mainly children and young people. Museum exhibitions were visited by 18.8 thousand people.

A new field station of Ecological Education was opened in November in Suche Rzeki.

In 2019 number of publications were issued:

- 27th volume of Roczniki Bieszczadzkie (Annals of Bieszczady);
- Brochure 'Discover and protect the BdPN natural heritage - educational offer';
- BNP Nature Calendar for 2020;
- A nature and touristic map of Bieszczady National Park with an booklet.

In addition, multimedia presentation included:

- Series of educational films "Bieszczady National Park - our common heritage". Emitted on TVP3 Rzeszów, around 2 million recipients.
- Panel for children "Wild kingdom of the Ryś Pędzelek" on [www.bdpn.pl](http://www.bdpn.pl) Number of viewers: about 1900,
- Series of radio plays on the Polish Radio Rzeszów around 98,000 listeners.
