The Burren Programme (BP) is funded under Ireland's Rural Development Programme (2014-2020) with 5-year contracts awarded to participating farmers, some of which will run until 31/12/2022. It now appears likely that the new CAP and National CAP Strategic Plan will be delayed beyond 2020 and, as a result, detailed discussions on its content have not yet commenced.

Details of the successor programme to the BP will be shared with EDPA group of specialists, but details will probably not be available until 2022.

In the meantime, positive preliminary discussions continue to take place with the Department of Agriculture, Food and the Marine (DAFM) regarding the continuation of the BP, which remains a flagship programme nationally and internationally.

- 1. prepare an overarching management framework document for the Burren Region diploma-holding area, outlining the various management initiatives and their inter-relationships; An 'Entity relationship diagram' for the Burren Programme (managed by HNVS Ltd) was attached to the 2018 report. There are no updates to this diagram in 2019.
- 2. aim both to increase the quality of the natural heritage and to prevent damage to the cultural heritage in those areas of the Burren Region not included within the three Special Areas of Conservation; Approximately 5% of the BP area is non-designated, Annex I habitat and the BP team continue to ensure that no damage is done to these areas.

Non-designated Annex I habitat outside of the BP is protected under Local Authority plans or through DAFM EIA rules. Any instances of damage being reported or witnessed is reported immediately by the BP team to the Local Authority.

3. work with other stakeholders, especially those involved in tourism predicated on the farm holdings, as well as the natural and cultural heritage, to support communities living and working in the Burren Region; The BP, with support from Leader, organised courses for local farmers on 'Setting up your own Business' as a way of encouraging and assisting Burren farmers to explore other business options on their land. The Burrenbeo Trust worked with a US company, Grand Circle Tours, to bring 80 groups of tourists to the Burren in Summer 2019 to visit one of three Burren farms for a farmer-led walk across the land. This was very successful and additional groups are expected in 2020.

In addition, 2-day training courses for public officials were held in 2019 as part of the Burrenbeo Learning Landscape initiative, with local farmers heavily involved in delivering the training.

The BP has provided support to the Burren farming community to explore the establishment of a Beef Producer Group in the Burren.

There are no current plans to extend trails in the Burren.

The focus of Burrenbeo Trust and the BP has been to develop farmer-led walks across the Burren. Training has been provided to farmers and several farmers were supported to hold public walks on their land through Burrenbeo's 2019 Monthly Walks programme.

The Burren Programme Team remain in place with 6 FTE working with the 328 farmers in the Programme, farming 23,200ha of habitat.

The Burrenbeo Trust continues its work in the Burren with its 3 P/T staff

The Burren Geopark Team (Project manager and F/T Geologist) and Burren Ecotourism Network (who have recruited a new manager) both continue their work.

Two NPWS rangers continue to work in the Burren.

There have been no changes in the EDPA boundary for the Burren in 2019

The tradition of Winterage, which is so central to the management of the Burren EDPA, was recognised by the Irish Government in July 2019 through its inclusion in Ireland's list of Intangible Cultural Heritage.

The Burren Winterage Weekend was held again in October 2019 and included an international conference on high nature value farming, a national 'farming for nature' awards night, and a widely-publicized cattle drove. The Burren in Bloom festival and Learning Landscape Symposium were also organized by Burrenbeo in 2019, all events supporting the local economy and reinforcing the conservation importance of the Burren.

Burrenbeo also carried out 10-week heritage-education courses in local schools (8 primary,2 secondary) and organised monthly heritage walks and a series of Winter talks.

Burrenbeo and the BP hosted a large number of national and international study groups with a priority given to groups of farmers interested in the conservation of their own landscapes. Visitors in 2019 included the King and Queen of Sweden.

The work of the BBT and BP featured in several National TV, Radio stations and in Newspapers in 2019.
