1. clarify by 2020 the status of the three units withdrawn from the management of the Tsentralno-Chernozemny Strict Nature Reserve (Janskoy, Lycie Gory and Stinky Izgoria) in 1990 and entrusted since then to the Belogorye Strict Nature Reserve; maintain, if possible, these three units within the diploma-holding area given their contribution to its European significance;

In accordance with this Administration of the reserve emphasizes the following:

At the present time three sites (Yamskoy, Lysyye Gory, St'enki Izgoria) belong to the State Nature Reserve «Belogorye» and status of these three units has not been changed in 2019. Administration of Tsentralno-Chernozemny Reserve plans to offer to the Administration of Reserve «Belogorye» to conclude an agreement about maintaining the status of these sites as the holders of the European Diploma for Protected Areas.

1. ensure that the necessary funding for the diploma-holding area is provided for in the federal budget and obtain greater financial support from the Kursk regional authorities;

2. draft and implement a programme to update and renovate the museum;

3. ensure that the current project for the extension of the biosphere reserve is completed as soon as possible and link it by 2022 to a management plan for the buffer and transitional zones in particular, thereby ensuring the European significance of the diploma-holding area and maintaining its integrity;

4. continue and strengthen the international co-operation efforts of the Tsentralno-Chernozemny Strict Nature Reserve by means of projects that meet the major interests of steppe environments in this part of Europe and which contribute to meeting the Aïchi Biodiversity targets.

In accordance with these items Administration of the reserve emphasizes the following:

1. An agreement about paid services was concluded with Kursk Nuclear Power Plant (Kursk NPP) in 2017 for 3 years (2017-2019) in the amount of 1.38 million RUB for biological monitoring of the environment in the buffer zone of Kursk NPP. Besides, in 2019 an agreement was concluded with the Mikhailovsky Mining and Processing Integrated Works for the study of the biological diversity (flora and fauna) of technogenic objects in the amount of 1.25 million RUB. Also, in 2019 1.0 million RUB was received as charity from the Kursk NPP. Funding from the Kursk regional authorities was not allocated.

2. This year, the current repair of the Museum of Nature of the Reserve was completed from the financial resources allocated by the Kursk NPP.

3. Whole set of documents for establishing a biosphere range "Stepnoy" was sent to the Ministry of Natural Resources and Ecology of the Russian Federation in 2016. However, in connection with the organizational circumstances (personnel movements and formation of new department in the Ministry of Natural Resources and Ecology) creating of biosphere range was suspended. At the present time in light of different reasons the Ministry of Natural Resources and Ecology is inclined to the option of establishing a new site of the Reserve, rather than the biosphere range. To initiate its creation, it is necessary to submit to the Ministry of Natural Resources of Russia the borders of the proposed protected areas in a new format. The reserve has taken the necessary measures to obtain borders in new format and will submit them to the Ministry of Natural Resources of Russia before the end of this year.

4. Tsentralno-Chernozemny Reserve continues working towards the international co-operation in the interest of saving steppe environments. The Reserve received in its territory in August 2019 participants of the 3 MUGIS 2019 Summer School "Anthropogenic and natural soil landscapes: from sea to sea" during field tour program. The group was comprised of delegates from China, USA, Germany and Russia.

No changes of the territory of the reserve took place in 2019, also the stuff number of employees and total funding remained practically at the previous level.

The problem of cooperation between Administration of reserve and Administration of Kurskaya oblast in the buffer zone of the reserve escalated in 2018. The whole existing at the present time buffer zone of the reserve (3 km around 4 sites of the reserve) in the end of 2017 – beginning of 2018 was put on cadaster and expressed on public cadastral map. Administration of Kurskaya oblast tried to challenge in court the cadastral registration of the buffer zone of the reserve, however the court left the decision unchanged. Besides, Investigating Committee of Kurskaya oblast opened a criminal case in relation to unidentified persons of Administration of Kurskaya oblast upon illegal issuance of building permits for individual dwellings in the buffer zone of the reserve.

Currently, the reserve has won (in the Kursk Regional Court) 27 lawsuits from citizens trying to put their unfinished residential buildings in the buffer zone of the reserve for state cadastral registration. The work is not finished yet and will continue in 2020. Also, in relation to one commercial building, there is a decision of the Kursk Regional Court on its demolition.

The Supreme Court of the Russian Federation in November 2019 confirmed the legitimacy of the Regulation on the buffer zone of the Tsentralno–Chernozemny Reserve, which was adopted in 1988.

Also, because of the cadastral registration of the buffer zone of the reserve the decision about building pigbreeding complex of "Miratorg" holding in the buffer zone of the Kazatskiy site of the Tsentralno– Chernozemny Reserve was suspended.

In light of the situation in the buffer zone of the Tsentralno–Chernozemny Reserve, Administration of the reserve emphasises a high value of the European Diploma, the existence of which among other things provided opportunity to draw the attention of local media and law-enforcement authorities to the problems of the reserve.
