- 1. By the Decision No. 1674-L of September 28, 2023, "On Amendments and Additions to the Decision No. 1978-L of December 26, 2019" of the Government of the Republic of Armenia", the action plan for 2023-2025, arising from the National Strategy for the Protection of Human Rights, has been approved, in which Article 4.8 envisions the adoption of the draft law "On National Minorities". The purpose of the latter is to regulate relations concerning the exercise of the rights of persons belonging to national minorities, to define the issues faced by the state and local self-government bodies in relation to them, and to establish organizational and legal foundations for the formation and operation of the Chamber of National Minorities. Thus, to contribute to the realization of the rights of national minorities, discuss the situation and problems concerning their realization, prepare proposals for problem resolution, and express a position, the creation of a Chamber of National Minorities is planned. It is planned to empower the chamber, among other things, with the function of monitoring the implementation status of the rights of persons belonging to national minorities.
- 2. The relevant information about national minorities is posted on the websites of the Marzpetarans (regional administrations) of Republic of Armenia and is linked to the website of the Government of the Republic of Armenia. In addition, the Marzpets (Governors) were instructed and the Mayor of Yerevan was suggested by the Minister of Territorial Management and Development to single out a "National Minorities" sub-section in the "General Information" section on the websites of the Marzpetarans and Yerevan Municipality, inserting there the necessary information about national minorities, including their number, history, monuments, and cultural events, as well as the progress made. Issues related to them, news, relevant legal acts, annual reports, congratulatory messages dedicated to national holidays are posted.

e. Increase the funding to the national minority associations so as to ensure the promotion of Assyrian in different fields of public life

3. The provision of financial support from the state budget of the Republic of Armenia to the educational and cultural activities of non-governmental organizations of national minorities continued, which has doubled since 2012, reaching 20 million drams. The mentioned amount was also planned for 2019-2023 with the state budget: The amount has not changed, despite the

additional burden on the RA state budget caused by the Corona epidemic, the 44-day war, and the forced displacement of the population from Nagorno Karabakh in 2023.

- f. Teach Assyrian as an integral part of the curriculum in technical and vocational education.
- 4. In 2019-2023, a number of steps were taken to strengthen and improve the quality of the teaching of the languages of national minorities in public schools (articles 7 and 8 of the report). Technical and vocational educational programs in the languages of most national minorities are impossible due to the limited number of native speakers, their scattered geographical distribution across Armenia, and the low demand, or absence of demand, for some languages.

Although German is not included in the list of minority languages of the Republic of Armenia within the meaning of the European Charter of Regional or Minority Languages, in the academic year 2023-2024, German was taught as a foreign language in 225 public and private, primary and secondary schools.
- 15. Since 2017, Yerevan State Humanitarian College has started cooperating with the German organization ZfA (Center for Foreign Schools). During each academic year, about 700 students of the College study German as a 2nd foreign language and at the end of the year more than 20 students pass the German language proficiency certificate exam, most of which secure the DSD 1 (B1) level. Since 2020, the college has held exams for DSD 2 (B2 / C1) level, in which more than 10 students have participated every year. All of them provide B2 or C1 level. In order to improve the German language in the college, a German lecturer teaches, and the college lecturers, within the framework of the above mentioned program, are regularly trained in the Federal Republic of Germany. In 2022-2023, by participating in international retraining courses for DSD 1 and DSD 2 examiners, they received international DSD 1 and DSD 2 examiner certifications.

16. German is taught as a foreign language in 13 higher education institutions, in 7 of them as a main subject. There are separate chairs of German in 3 universities, and in 6 universities it is included in the Chair of Foreign Languages.
