Synopsis

of the meetings held in Strasbourg on 28 and 30 January 2025

The Committee on Culture, Science, Education and Media, meeting in Strasbourg on Tuesday 28 and Thursday 30 January 2025, with Lord George Foulkes (United Kingdom, SOC), the oldest member present, then Ms Linda Hofstad Helleland (Norway, EPP/CD), Chairperson, Mr Yunus Emre (Türkiye, SOC), 3rd Vice-Chairperson, and Ms Belén Hoyo (Spain, EPP/CD), 2nd Vice-Chairperson, in the Chair,

- Tuesday 28 January 2025 at 14:00, as regards:
- Opening of the meeting by the oldest member present:
 - welcomed representatives of the delegation of Belarusian democratic forces, as approved by the Bureau of the Assembly,
 - decided to open its 2025 meetings to elected representatives of the Turkish Cypriot Community¹;
- Election of the Bureau of the committee: elected by acclamation:
 - Ms Linda Hofstad Helleland (Norway, EPP/CD), Chairperson,
 - Ms Fiona O'Loughlin (Ireland, ALDE), 1st Vice-Chairperson,
 - Mr Yunus Emre (Türkiye, SOC), 3rd Vice-Chairperson;
- Communication from the Chairperson of the committee:
 - took note of the reply from FIFA to the letter sent by the Chairperson of the committee concerning
 the decision on the host country of the 2034 FIFA World Cup, and, on the basis of a proposal from
 the Chairperson, agreed to pursue the dialogue with FIFA through a visit to Zurich, Switzerland, of
 a delegation of committee representatives, subject to the availability of funds;
 - was informed about the contentious relationship between the World Anti-Doping Agency (WADA)
 and US Anti-Doping Agency (USADA) which led to calls for reform remaining unresolved, and, on
 the basis of a proposal from the Chairperson of the committee, agreed that the committee and the
 Parliamentary Alliance for Good Governance and Integrity in Sport should play a role and plan
 further discussions on the subject;
 - took note of the information memorandum on "Gender equality in the functioning of the Assembly in 2024", prepared by the Secretariat of the Committee on equality and Non-Discrimination;
 - was informed that the meeting of the committee scheduled to take place in Norway on 3 and 4 June 2025 will be held in Trondheim;

- Multiperspectivity in remembrance and history education for democratic citizenship (Rapporteur: Ms Luz Martínez Seijo, Spain, SOC): took position on 7 amendments and voted unanimously and tabled 2 written sub-amendments to the draft resolution; took note that there were no amendments to the draft recommendation; heard a brief presentation by Mr Rafal Rogulski, Director of the European Network on Remembrance and Solidarity (ENRS), about the exhibition "Between life and death" related to the report;
