Synopsis

of the meeting held in Strasbourg on 1 and 3 October 2024

The Committee on Culture, Science, Education and Media, meeting in Strasbourg on Tuesday 1 October and Thursday 3 October 2024, with Lord George Foulkes (United Kingdom, SOC) in the chair,

- Tuesday 1 October 2024 from 8:30 to 10:00, as regards:
- **Propaganda and freedom of information in Europe** (*Rapporteur: Mr Stefan Schennach, Austria, SOC*): took position on 6 amendments and 2 sub-amendments to the draft resolution;
- Institutional representation:
 - Appointment of a representative to the Council of Europe Committee for Works of Art (C-ART): designated, for her appointment by the Bureau of the Assembly, Ms Luz Martínez Seijo (Spain, SOC) as representative, and heard her declaration of absence of conflict of interests;
