Synopsis of the meetings held in Strasbourg on 9, 10 and 12 October 2023

The Committee on Migration, Refugees and Displaced Persons, meeting in Strasbourg, on 9, 10 and 12 October 2023, with Mr Theodoros Rousopoulos (Greece, EPP/CD), in the Chair,

- on Monday 9 October, from 13:00 to 13:30, as regards:
- Possible debate under urgent procedure on the "Humanitarian situation in Nagorno-Karabakh"¹: appointed Mr Domagoj Hajduković, (Croatia, SOC) as rapporteur for report and heard his declaration of absence of conflict of interest;
- Lampedusa: European solidarity as a necessity for the dignified reception of refugees: considered and adopted a draft declaration on behalf of the Committee, proposed at the initiative of Mr Emmanuel Fernandes (France, UEL);
- on Tuesday 10 October 2023, from 8:30 to 9:30, with Mr Theodoros Rousopoulos (Greece, EPP/CD), in the Chair, as regards:
- Debate under urgent procedure on the "Humanitarian situation in Nagorno-Karabakh: considered a draft report and adopted a draft resolution and a draft recommendation;
- on Tuesday 10 October 2023 from 10:30 to 12:30, as regards:
- Dialogue with the representatives of the Russian democratic forces sharing the Council of Europe values, follow-up to Assembly 2433 (2022) and 2473 (2022)":
 - held a hearing with the democratic Russian opposition forces with the participation Ms Natalia Arno, President of the Free Russia Foundation; Mr Gennady Gudkov, former member of the Duma, Chairman of "For a Free Russia"; Mr Sergei Guriev, Russian Anti-War Committee, True Russia Project; Ms Evgenia Kara-Murza, wife of jailed Russian opposition leader and 2022 Václav Havel Prize laureate Vladimir Kara-Murza; Mr Mikhail Khodorkovsky, Russian Anti-War Committee, Russian Action Committee (online); Ms Ekaterina Shulman, political scientist, academic and commentator; with the participation also of Mr Tiny Kox, President of the Parliamentary Assembly;
 - took note of the intention of the President of the Assembly to establish a regular contact platform for dialogue with representatives of Russian democratic forces who share Council of Europe values, fully respect Ukraine's territorial integrity and condemn the Russian Federation's war of aggression against Ukraine;

- on Thursday 12 October 2023, from 8:30 to 10:00, as regards:
- Human rights and humanitarian situation of Karabakh Armenians and international obligations of Azerbaijan: held a joint hearing with the Committee on the Honouring of Obligations and Commitments by Member States of the Council of Europe (Monitoring Committee) and the Committee on Legal Affairs and Human Rights (recorded and broadcasted via YouTube with the agreement of the experts), with the participation of Mr Thomas de Waal, London, United Kingdom (online); Mr Andreas Wissner, Representative, UNHCR Representation to the European Institutions in Strasbourg; and Prof. Dr. Björn Schiffbauer, Professor of Public Law, European and International Law, University of Rostock, Germany;
- on Thursday 12 October 2023, from 10:00 to 12:30, as regards:
- Debate under urgent procedure on the "Humanitarian situation in Nagorno-Karabakh": took
 position on 29 amendments which had been tabled to the draft resolution and 9 amendments which had
 been tabled to the draft recommendation;
- The theme of migration and asylum in the election campaign and the consequences on the welcoming and rights of migrants (Rapporteur: Mr Pierre-Alain Fridez (Switzerland, SOC), (taking position on amendments): postponed this item given the postponement of the consideration of the item by the Assembly to 2024;
- The humanitarian crisis emerging for Afghanistan and Afghan refugees: took note that no amendments had been tabled;
- Immigration, one of the answers to Europe's demographic aging: held an exchange of views with the
 participation of Mr Xavier Devictor, Co-Director for the World Development, Report 2023, The World Bank;
