Synopsis

of the meeting held in Ljubljana, Slovenia, on 17 and 18 October 2024

The Committee on Migration, Refugees and Displaced Persons, meeting in Ljubljana, Slovenia, on 17 and 18 October 2024 with Mr Oleksii Goncharenko (Ukraine, EC/DA), Chairperson, in the Chair, with the participation of Ms Despina Chatzivassiliou-Tsovilis, Secretary General of the Parliamentary Assembly:

- on Thursday, 17 October 2024 from 09:30 to 13:00, as regards:
- Welcome address: heard a welcome address by Ms Urška Klakočar Zupančič, President of the National Assembly, Republic of Slovenia and Ms Tamara Vonta, Chairperson of the Slovenian Delegation to the Parliamentary Assembly;
- Declaration on the occasion of the European Anti-Trafficking Day: considered and unanimously adopted
 the draft declaration calling for greater protection of migrant workers against labour exploitation in line with
 CM/Rec(2022)21 on preventing and combating trafficking in human beings for the purpose of labour
 exploitation;
- Putting an end to collective expulsions of aliens (Rapporteur: Mr Pierre-Alain Fridez, Switzerland, SOC):
 held an exchange of views with the participation of Dr Polona Mozetič, expert at the Human Rights Ombudsperson's office of the Republic of Slovenia;
- Artificial Intelligence (AI) and Migration (Rapporteur: Mr Petri Honkonen, Finland, ALDE): considered a
 draft outline; held an exchange of views with the participation of Dr Aleksander Pur, expert on AI and security
 and of Ms Petra Molnar, Associate Director, Refugee Law Lab, York University (online);
- Exchange of views with the participation of Mr David Best, Special Representative of the Secretary General of the Council of Europe on Migration and Refugees, on 2025 outlook: held an exchange of views:

 heard her statement;
- Follow-up on report on "A shared European approach to address migrant smuggling" (Rapporteur: Lord Simon Russell, United Kingdom, EC/DA): heard a report back by the Rapporteur about his participation in the 2nd International Conference on Migrant Smuggling, on 10-11 September 2024, at the Council of Europe; held an exchange of views with the participation of Mr Robert Renier, Senior State Prosecutor-Counsellor, Head of District State Prosecutor's Office in Krško and member of the Council of Europe Network of Prosecutors on Migrant Smuggling;
- Saving migrants' lives at sea and protecting their human rights (Rapporteur: Mr Paulo Pisco, Portugal, SOC): held an exchange of views with the participation of Dr Omer Shatz, Legal Director at front-LEX and Senior Fellow, Rule of Law clinic, the Democracy Institute, Central European University (CEU), and of Ms Anna di Bari, Board Member at Sea-Eye;
- Ad hoc Sub-Committee to carry out a fact-finding visit to Sicily (Italy): heard an oral report by Mr Paul Gavan (Ireland, UEL), Chairperson of the ad hoc Sub-Committee, of the conclusions of the fact-finding visit

to Sicily (16-18 September 2024); and decided to declassify the report related to this visit in the aim to publish it on the Parliamentary Assembly website;
