Synopsis of the meetings held in Strasbourg from 27 to 30 January 2025

The **Committee on Political Affairs and Democracy**, meeting in Strasbourg from 27 to 30 January 2025, with first Lord David Blencathra (United Kingdom, ECPA), oldest member present, then Mr Bertrand Bouyx (France, ALDE), Chairperson, in the Chair:

• on Monday 27 January 2025 at 14:00, as regards:

– Election of the Bureau of the Committee:

re-elected, by acclamation:

- Mr Bertrand Bouyx (France, ALDE), Chairperson,
- Mr George Papandreou (Greece, SOC), 2nd Vice-Chairperson,
- Ms Elisabetta Gardini (Italy, ECPA), 3rd Vice-Chairperson;

and elected, by acclamation, Ms Yelyzaveta Yasko (Ukraine, EPP/CD), 1st Vice-Chairperson;

- **Constitution of sub-committees**: reconstituted the Sub-Committee on External Relations, the Sub-Committee on the Middle East and the Arab World, and the Sub-Committee on the Western Balkans;
- Debate under urgent procedure: The urgent need for free and fair elections in Belarus: appointed Mr Ryszard Petru (Poland, ALDE) as rapporteur and heard from him a declaration of absence of conflict of interest;
- Debate under urgent procedure: European commitment to a just and lasting peace in Ukraine: appointed Ms Miapetra Kumpula-Natri (Finland, SOC) as rapporteur and heard from her a declaration of absence of conflict of interest;
- Situation in the Middle East (rapporteur: Ms Dora Bakoyannis, Greece, EPP/CD): held a hearing with the participation of Ms Signe Brudeset, Director General at the Department for Regional Affairs, Norwegian Ministry of Foreign Affairs (online), followed by an exchange of views;
- Co-operation with the Canadian Observer delegation: held an exchange of views with the Canadian Observer delegation;
- Standing invitations: decided, in accordance with Resolution 1376 (2004) and following the decision of the Bureau of the Assembly of 4 October 2004 approved the same day by the Assembly, and according to Article 48.7 of the Rules of Procedure, to invite the elected representatives of the Turkish Cypriot community to attend its meetings during the Assembly 2025 Ordinary Session; also decided, in accordance with Resolution 2530 (2024), that the representative delegation of Belarusian democratic forces attending its meetings during the Assembly 2025 Ordinary Session would have the right to speak;
- on Tuesday 28 January 2025 at 8:30, as regards:
- **Sub-committees**: approved the composition of the sub-committees (see Appendix);

- Institutional representation: in the framework of the Assembly's institutional representation, and taking into account Assembly Resolution 2394 (2021) "Gender representation in the Parliamentary Assembly", appointed the following members and substitutes, for submission to the Bureau of the Assembly:
 - Council for Democratic Elections of the Venice Commission (CDE):

Member: Mr Titus Corlățean (Romania, SOC), following a vote;

- European Commission against Racism and Intolerance (ECRI):

Member: Ms Sibel Arslan (Switzerland, SOC), by acclamation, Substitute: Mr George Loucaides (Cyprus, UEL), by acclamation;

- The need for a renewed rules-based international order (rapporteur: Ms Dora Bakoyannis, Greece, EPP/CD): took position on 27 amendments to the draft resolution and on 2 amendments to the draft recommendation, and decided to support one oral sub-amendment to the draft resolution;
- Elections in times of crisis (rapporteur: Mr Damien Cottier, Switzerland, ALDE): heard a statement by Lord David Blencathra (United Kingdom, ECPA), Chair-designate of the Parliamentary Assembly Network of Election Observers;
- Interconnections between the Council of Europe and the European political community (rapporteur: Mr Zsolt Németh, Hungary, ECPA): heard a statement by the rapporteur and authorised him to carry out a fact finding visit to Paris on 4 March 2025 (subject to the availability of funds);
- on Tuesday 28 January 2025 at 14:00, as regards:
- **The urgent need for free and fair elections in Belarus** (rapporteur: Mr Ryszard Petru, Poland, ALDE): considered a draft report and unanimously adopted a draft resolution as amended;
- European commitment to a just and lasting peace in Ukraine (rapporteur: Ms Miapetra Kumpula-Natri, Finland, SOC): considered a draft report and unanimously adopted a draft resolution as amended;
- General Rapporteur on democracy: appointed Mr George Papandreou (Greece, SOC) for a second mandate as General rapporteur on Democracy and heard from him a declaration of absence of conflict of interest;
- **General Rapporteur on Russian democratic forces** (General Rapporteur: Mr Eerik-Niiles Kross, *Estonia, ALDE*): heard a statement by the General Rapporteur, followed by an exchange of views;
- A closer cooperation between the Parliamentary Assembly of the Council of Europe and the United States Congress: approved a motion for a resolution to be tabled on behalf of the committee;
- Work programme:
 - **Reference for consultation**: "Safeguarding the rule of law in Tunisia", decided to advise the Bureau that this reference be referred to the committee for report;
 - **Reference for information**: took note of the reference on "The use of artificial intelligence in public decision-making processes and its impact on human rights";
 - **Gender equality in the functioning of the Assembly**: took note of the Information memorandum prepared by the Secretariat of the Committee on Equality and Non-Discrimination;
 - Reporting back: heard from Mr George Papandreou (Greece, SOC) about his participation in the OECD Global Forum on "Building Trust and Strengthening Democracy", in Milan (Italy), on 21-22 October 2024; in the 2nd meeting of the Steering Committee for Democracy (CDDEM), in Strasbourg, on 29-30 October 2024; in the World Democracy Forum, in Strasbourg, on 6-8

November 2024; and in the Seminar on "Private Powers and the Rule of Law", Madrid 28-29 November 2024;

- Authorisations: authorised Mr George Papandreou (Greece, SOC) to participate online in the conference on "Citizen participation in the climate crisis: building a permanent citizens" parliament for the climate', on 29 January 2025; to attend the Summit for Action on AI, in Paris, on 10 and 11 February 2025; and to attend the Munich Security Conference, in Munich, from 14 to 16 February 2025 (subject to the availability of funds);
- Increasing members' active participation in and contribution to the work of the Parliamentary Assembly and its committees: took note of the introductory memorandum of the Committee on Rules of Procedure, Immunities and Institutional Affairs;
- on Thursday 30 January 2025 at 8:30, as regards:
- **The urgent need for free and fair elections in Belarus** (rapporteur: Mr Ryszard Petru, Poland, ALDE): took position on two amendments tabled to the draft resolution;
- European commitment to a just and lasting peace in Ukraine (rapporteur: Ms Miapetra Kumpula-Natri, Finland, SOC): took position on nine amendments tabled to the draft resolution, and decided to support two oral amendments and one oral sub-amendment;
- Strengthening mechanisms for early warning and action in conflict prevention (rapporteur: Ms Yelyzaveta Yasko, Ukraine, EPP/CD): considered an outline report, followed by an exchange of views;
- Institutional representation: appointed, by acclamation, Mr Michael Georg Link (Germany, ALDE) substitute member of the Council for Democratic Elections of the Venice Commission (CDE), for submission to the Bureau of the Assembly;
- Work programme:
 - **Appointment of Rapporteurs for report**: appointed, by acclamation:
 - Mr Andrej Hunko (Germany, UEL) as rapporteur on "Strengthening freedom of expression: an imperative for the consolidation and development of democratic societies", subject to hearing from him a declaration of interest;
 - Mr George Papandreou (Greece, SOC) as rapporteur on "A closer cooperation between the Parliamentary Assembly of the Council of Europe and the United States Congress", subject to the motion being referred to the committee, and heard from him a declaration of absence of conflict of interest; authorised him, in the framework of his report, to carry out a factfinding visit to Washington on 12 and 13 March 2025 to meet with representatives from the United States Congress and the State Department (subject to the authorisation of the Bureau and to the availability of funds);
 - Declaration of conflict of interest: heard a declaration of absence of conflict of interest from Mr George Loucaides (Cyprus, UEL), rapporteur for "Shaping the Parliamentary Assembly's relations with the United Nations Human Rights Council";
- Ad hoc Committee of the Bureau to participate in the parliamentary <u>conference</u> on "Envisioning effective public policy to prevent & address cases of missing migrants", organised as a follow-up to Resolution 2569 (2024) "Missing migrants, refugees and asylum seekers – A call to clarify their fate", in Strasbourg, on 23-24 April 2025: called for candidates and took note of the interest of Mr Piero Fassino (Italy, SOC) to participate in the conference;
- Parliamentary Network for a healthy environment: appointed Ms Lesia Vasylenko (Ukraine, ALDE) to participate in the Network;
- Ad hoc Committee of the Bureau to participate in the meeting between parliamentarians from the Nordic Council and the Parliamentary Assembly of the Council of Europe (PACE), in Kristiansand, Norway, on 4-5 May 2025: took note of the interest of Ms Ingjerd Schie Schou (Norway, EPP/CD) and Mr Stephen Gethins (United Kingdom, NR) to participate in the conference;

- Václav Havel Human Rights Prize 2025: took note of the deadline of 30 April 2025 for the submission of nominations;
- Invitation to hold a meeting in Greece in May 2025: took note of, and welcomed, the proposal from Ms Dora Bakoyannis (Greece, EPP/CD), Chairperson of the Greek delegation to the Assembly, to hold a meeting in Greece in May 2025 (date to be confirmed and subject to the authorisation of the Bureau);
- on Thursday 30 January 2025 at 14:00, as regards:
 - Ukrainian prisoners of war, journalists and other civilians held in captivity by the Russian Federation: held a joint hearing with the Committee on Legal Affairs and Human Rights, the Committee on Migration, Refugees and Displaced Persons and the Committee on Culture, Science, Education and Media, with the participation of Mr Maksym Butkevych, Human rights defender, officer of the Ukrainian Armed Forces, ex-POW, journalist; Ms Leniie Umerova, recently exchanged Crimean Tatar and civilian hostage (Ukrainian citizen); Mr Yulian Pylypei, Ukrainian marine, Mariupol defender, 2.5 years in Russian captivity; Ms Nataliia Yashchuk, Senior War Consequences Officer, Center for Civil Liberties, Kyiv, followed by an exchange of views;
