**Jeremy McBride, President**

*Barrister, Monckton Chambers, London, specialising in cases before the European Court of Human Rights and the UN Human Rights Committee. Scientific Expert for the adoption of the Fundamental Principles on the Legal Status of NGOs and the Recommendation on the Legal Status of NGOs in Europe (CM/Rec(2007)14). Member of the ODIHR-Venice Commission Expert Working Group for the preparation of the Joint Guidelines on Freedom of Association. Co-founder and former Chair of INTERIGHTS (International Centre for the Legal Protection of Human Rights). Formerly, Reader in International Human Rights Law, University of Birmingham and visiting Professor, Central European University. Mr McBride resides in Strasbourg.*



**Pavel Chikov**

*Human rights lawyer and head of the Agora International Human Rights Group, member of the Presidential Council of Human Rights (Russia). Law School (Kazan State University, Russia) and MPA (University of North Dakota, USA) graduate, PhD in International Law. He has been working in the human rights field since 1999, organizing legal defence for hundreds of criminal cases against civic and political activists, bloggers and journalists. His team represents dozens of Russian NGOs that faced a lot of pressure since 2006, including the so-called Foreign Agents Law. Pavel Chikov resides in Kazan, Russia.*



**Simona Constantinescu**

*Legal expert actively working for a more favourable environment for civil society organizations for over 20 years. She started as a lawyer and since 2011 served as Head of Development and Advocacy for Civil Society Development Foundation. She managed grant-making programmes involving more than 250 NGOs and has been engaged in major advocacy campaigns for improving the legislation. She led or was part of some dozens of working groups on legislative changes affecting the third sector, either as legal writer, researcher, spokesperson or advocate for change at Romanian and international level. *Co-founder and legal coordinator of the NGO "European Prison Litigation Network". *Professor in the law faculty at the University of Essex and Director of the Essex Human Rights Centre (October 2024 - present). She also worked with the UN High Commissioner for Human Rights in Rwanda (1995 – 1997), Amnesty International (1998 – 1999) and was Executive Legal Advisor of the Commission for Real Property Claims of Refugees and Displaced Persons in Bosnia and Herzegovina (1999 – 2001). She also served on the panel of judges of the Aban Tribunal, an International People’s Tribunal on Iran’s Atrocities in the context of a crackdown on country-wide protests in November 2019. *Australian qualified lawyer currently working as Deputy Director of an NGO that supports and campaigns alongside individuals in immigration detention.
