AS SOON AS THE ABOVE REFERRED LAW WAS ENACTED, I WAS APPOINTED AS CHIEF PUBLIC PROSECUTOR AND BEGAN TO ORGANIZE THE PRESENT OFFICE'S FRAMEWORK WHICH IS INTEGRATED BY 170 ESPECIALIZED PROSECUTORS AS WELL AS A TECHNICAL TEAM, COMPOSED BY SEVERAL MEMBERS OF THE POLICE FORCES AND SCIENTISTS SPECIALIZED ON ENVIRONMENT.

MY PRESENT WORK REQUIRES AN IMPORTANT AMOUNT OF ORGANISATIONAL SKILLS,

ESPECIALLY CONSIDERING THAT MY JURISDICTION AND COMPETENCE EXTENDS TO THE WHOLE COUNTRY. MY TWO BASIC TASKS, AS CHIEF PUBLIC PROSECUTOR ON ENVIRONMENT, CONSIST OF COORDINATING ALL ENVIRONMENTAL CASES INITIATED BY SPECIALISED PUBLIC PROSECUTORS, AND LEADING INVESTIGATIONS OF SERIOUS CASES OR WHEN THEY TAKE PLACE IN MORE THAN ONE AUTONOMOUS REGION IN SPAIN. SINCE THE MOMENT WHEN THE PUBLIC PROSECUTOR'S OFFICE WAS CREATED, WE MANAGED TO DUPLICATE THE NUMBER CONVICTIONS WHICH HAVE BEEN ISSUED BY THE SPANISH COURTS. IN FACT, WHILE THERE WERE AROUND 300 CONVICTIONS ON 2006, IN 2015 THERE WERE 927 CONVICTIONS ISSUED BY THE SPANISH JUDICIARY.

EXPERIENCE DEMONSTRATES THAT AN IMPORTANT NUMBER OF CASES DEALT BY THE PUBLIC PROSECUTOR'S OFFICE ARE CONNECTED WITH CORRUPTION AND FRAUD, ESPECIALLY IN THOSE AFFAIRES RELATED TO LAND PLANNING OR URBANISM. IN FACT, SOME OF THE MOST IMPORTANT CASES OF CORRUPTION WHICH OCCURRED RECENTLY IN SPAIN (MÁLAGA, LANZAROTE, PALMA DE MALLORCA, MURCIA, ETC.) ARE BEING INVESTIGATED BY ANTI-CORRUPTION AND ENVIRONMENTAL SPECIALISED PROSECUTORS, UNDER A DUAL PROFESSIONAL SCHEME.
