Rafael Benitez

Director of Social Rights, Health and Environment, Council of Europe Rafael A. Benitez holds a Master's in European Law from the College of Europe and degrees in Law and Finance from ICADE - University of Comillas. He studied Political Science at UNED. Currently, he is the Director of Social Rights, Health, and Environment at the Council of Europe, where he has worked since 1994. His previous roles include Director of the Congress of Local and Regional Authorities and Chief of Protocol. Mr. Benitez has expertise in administrative law, international criminal justice, corruption, terrorism, and public international law. He has published works, spoken at international conferences, and lectured at ITI-RI and IIDH in Strasbourg. He speaks Spanish, English, French, and Italian.



Angela O'Hagan

Chair of Scottish Human Rights Commission Angela O'Hagan was most recently Professor of Equality and Public Policy at Glasgow Caledonian University. She was also Deputy Director of the WISE Centre for Economic Justice. Her career encompasses leadership roles in the community and statutory sectors in Scotland, including as Director of Carers Scotland, and Head of Campaigns and Communications with Oxfam Scotland, after a period with the Equal Opportunities Commission. She has served on a number of advisory and project groups with successive Scottish Governments including previously as a member of the Equality and Human Rights Budget Advisory Group, the National Advisory Council on Women and Girls, and the Commission on Local Tax Reform.



Tatiana Puiu

Vice President of the ECSR, Council of Europe **Tatiana Puiu** is an Attorney at Law in the Republic of Moldova and the Vice-President of the European Committee of Social Rights. Her professional experience in human rights and the rule of law spans legal, policy, and practical fields. Tatiana has served as an

expert advisor to a wide range of international and national organizations and bodies working on human rights issues, including the Council of Europe, OSCE, National Human Rights Institutions (NHRIs), and (I)NGOs.

Charlotte Altenhoener-Dion

Adviser, Office of the Commissioner for Human Rights, Council of Europe Charlotte Altenhöner-Dion has been Adviser to the Commissioner for Human Rights since 2020. She joined the Council of Europe in 2010, working six years in minority protection (FCNM) and four years on media freedom, internet governance and AI (CDMSI). Previously, she worked for ten years for the UNHCR, mainly in Central Asia and the Balkans, and gained further experience in international human rights protection with the UN, the OSCE, and NGOs in Colombia, the UK and the Netherlands. She studied law in Germany and France and holds an LLM in International Law from Georgetown University, US, where she was a Fulbright scholar.



Ana Winship

Research Fellow, Scotland's Rural College **Dr. Ana Winship** is a human geographer specializing in rural development, migration, and regional policy, with extensive interdisciplinary research experience across Europe and Australia. She focuses on the social and economic impacts of demographic change, land reform, and housing in rural and remote areas. Ana is currently a Research Fellow at the Rural Policy Centre (SRUC), co-leading and contributing to projects funded by the Scottish Government's Strategic Research Programme 2022-2027, British Academy, WHO, and Council of Europe. She also holds honorary and teaching roles at Charles Darwin University and the University of Edinburgh, supporting research and postgraduate education in rural development and ecological economics.

Tatjana VLAŠIĆ

Deputy Ombudswoman, Republic of Croatia **Tatjana Vlašić** holds an MA from the University of Zagreb and a joint MA in Democracy and Human Rights from the Universities of Sarajevo and Bologna. As a Fulbright Scholar, she specialized in anti-discrimination policies at UC Berkeley.

From 2008–2015, she worked in the Government Office for Human Rights and National Minorities, later joining the Ombudswoman's Office as advisor until her appointment as Deputy Ombudswoman. Her work has included managing projects, research, training, public campaigns, and international cooperation.

She has collaborated with the UN, UNHCR, Council of Europe, OSCE/ODIHR, and served as Croatia's liaison to the EU's Fundamental Rights Agency. She also teaches on anti-discrimination and constitutional rights, and contributed to the 2019 re-accreditation of the Ombudswoman's Office as a UN Status A institution.



Patrycja Pogodzinska

Policy Officer, EQUINET


