## **1. Opening of the meeting**

1. The CAHAI-LFG took note of the opening remarks by the Chair of the CAHAI, Mr Gregor STROJIN (Slovenia) who underlined that this is the 5<sup>th</sup> and final meeting of the Working Group. He congratulated all participants for their hard work, especially considering the difficult working conditions due to time constraints and the ongoing Covid19 pandemic, in identifying the elements of a legal framework on AI based on the Council of Europe standards on human rights, democracy, and the rule of law. He further stressed that this document is a key deliverable for the CAHAI and will undoubtedly play an important role in shaping the drafting and negotiation of future instruments, including a potential Council of Europe Convention.
2. Mr Strojin continued by adding that this document has put the verbal commitments of the CAHAI made over the course of the last two years onto paper. However, he reminded the Group that it is not mandated to draft a legal instrument, but rather to lay out the basic elements of the framework which will be extremely valuable for the next group(s) of experts who will, if the Committee of Ministers decides so, start drafting and negotiating the legal framework in 2022. He notably recalled, in light of the current negotiations of the COP26 meeting in Glasgow, earlier discussions about the need for sustainable AI and urged the Group to consider this aspect when finalising the “elements” document.
3. The CAHAI-LFG also took note of the opening remarks by Ms Claudia LUCIANI, Director, Directorate of Human Dignity, Equality and Governance, Council of Europe who underlined that it is of utmost importance that during these two days, the group focuses on finalising its work in time for the upcoming CAHAI plenary meeting on 30 November to 2 December. She further welcomed the fact that elements on democracy were reinforced in the document under discussion.
4. Ms Luciani wished to emphasise the importance of undertaking this work in a good working atmosphere, giving due respect to everyone's input and views and thus getting the best out of each and every delegate.
5. The Group finally took note of the opening remarks by Mr Jan KLEIJSEN, Director, Information Society - Action against Crime, who also thanked the participants for the enormous amount of work achieved, producing outstanding results under difficult circumstances. He informed the Group that discussions in the Committee of Ministers are ongoing regarding the format of the CAHAI for the coming years.
6. Mr Kleijssen also highlighted the impact of digital transformation on the environment and the need to include an element on sustainability in the current document. Mr Kleijssen brought to the attention of the Group the World Forum on Democracy taking place on 8 – 10 November on the topic of ‘Can democracy save the environment?’.

## **2. Adoption of the agenda**

7. The CAHAI-LFG adopted the agenda.

### **3. Introduction by the Co-Chairs and the Secretariat**

8. The Co-Chairs of the CAHAI-LFG, Ms Peggy Valcke (Belgium) and Mr Riccardo Villa (Italy) warmly welcomed all participants to this final meeting and thanked them for all their contributions so far to the “elements” document. They also underlined the importance of finalising this last deliverable during the meeting.

### **4. Information concerning the outcome of the sixth meeting of the CAHAI-PDG (11-12 October 2021)**

9. The Secretariat informed the Group that at its last meeting, the CAHAI-PDG approved two chapters to be included in the “elements” document on namely “Human rights, democracy, and rule of law impact assessment” and “Complementary elements relating to artificial intelligence in the public sector” (Chapters XII and XIII).
10. Following the meeting, the delegation of the Russian Federation informed the Secretariat that it could not support the approval of Chapter XII and the inclusion of Chapter XIII in the document.
11. The Secretariat underlined that during this meeting, discussions would be limited to Chapters I to XI and invited delegations to reserve possible comments on the two chapters prepared by the CAHAI-PDG for the upcoming CAHAI Plenary meeting (30 November – 2 December 2021).

### **5. Second reading of the draft document prepared by the Secretariat on the possible elements of a legally binding instrument on artificial intelligence, human rights, democracy, and the rule of law**

#### **Chapter II**

12. The Group held an exchange on whether or not “dual use” should be included under the scope of a Council of Europe legal instrument on AI, human rights, democracy and the rule of law. Some delegations stated that due to its complexity and the inherent difficulties in drawing a line between military use and civilian use over the lifecycle of an AI system, the question of including “dual use” under the scope of a Council of Europe instrument should be left for the Committee of Ministers to decide on.
13. The Russian Federation reserved its position on paragraph 6 concerning “dual use”.
14. The Group agreed to delete the word ‘significant’ throughout the text when referring to risk in order not to quantify a level of risk, as all risks could, in principle, cause harm.
15. The Russian Federation reserved its position on paragraph 10 mentioning Chapter XIII.

#### **Chapter V**

16. The element regarding risk classification was further developed to specify that it is based on an initial review to determine if a full impact assessment is required. The examples of categories of risks were also discussed and amended.

17. It was clarified that while the impact assessment should form a constitutive part of the possible legal instrument, the specific model ('HUDERIA') presented in the document would not necessarily be part of a future legally binding instrument.
18. The question of whether or not examples of potential "red lines" should be included was examined. Finally, while recognising the importance of specific issues such as the targeting of children, it was agreed to include more general illustrations in paragraph 21 upon which the Group could agree, namely certain uses of biometrics and social scoring.
19. The Russian Federation reserved its position on paragraph 21 concerning "red lines".
20. The Group agreed that wording should be added to specify that review procedures should be put in place for the reversal of a ban or moratorium should the risks be reduced or mitigation procedures put in place, so that the AI system no longer poses an unacceptable risk.

## Chapter VI

21. The text was amended to refer to "compliance" rather than "conformity" with existing standards. It was further agreed to add a reference to the amending Protocol to Convention 108. Certain delegations underlined the need to keep the text open enough to include states which are not party to a particular convention.
22. Concerning the concept of "unlawful harm", the Group agreed that this concept is difficult to define and the paragraph on this topic was rephrased to recommend that this complex issue be clarified for the purpose of a future legal instrument.
23. One delegation questioned the use of the term "gender equality" and suggested to instead refer to "equality between men and women". The Secretariat and the Chair of the CAHAI, Mr Gregor Strojin, underlined that gender equality is a term used extensively throughout the Council of Europe, including in the Terms of Reference of the CAHAI, and recalled that a gender equality rapporteur is appointed to the CAHAI.
24. The inclusion of a reference to vulnerable groups was widely supported by the Group.
25. The Group agreed to include a reference to sustainability of AI systems throughout their lifecycle as an issue to be borne in mind in future work. There was general agreement that environmental harm is an emerging area and that this is an important issue going forward.
26. The Russian Federation reserved its position on paragraph 30 concerning sustainability and AI.

## Chapter VI

27. Language was added to specify that concerns arise regarding AI and the public sector when AI systems are used to take or inform decisions that impact the rights and obligations of individuals and legal persons.
28. The reference to issues relating to private actors acting on behalf of public authorities was amended to clarify that in such context, Parties should ensure compliance with the standards concerning AI systems as regards human rights, democracy and the rule of law.

## Chapter VIII

29. It was deemed important to mention that the role of private entities which shape the public sphere should be considered in respect to concerns that the growing concentration of economic power and of data could undermine democratic processes. This was done in paragraph 37.

## Chapter XI

30. The Group debated whether to qualify the independence of national supervisory bodies as ‘functional’. It was agreed to remove the qualification of independence as ‘functional’.

31. The Russian delegation reserved its position on paragraph 43 due to the removal of the word “functional”.

### **6. Approval of the draft document and next steps**

32. The CAHAI-LFG approved the text as modified during the meeting. Ms Valcke informed the Group that the document would now be submitted to the CAHAI for finalisation at the upcoming Plenary meeting of 30 November to 2 December.

33. Both Co-Chairs thanked everyone who contributed to the drafting of this document for their hard work.

### **7. Any other business**

34. No issues were raised under this item.

### **8. Closing remarks by Mr Patrick PENNINCKX, Head of Information Society Department, Council of Europe**

35. Mr Penninckx thanked all participants involved for their hard work which has been an enormous collaborative effort, a feat not always easy in an international context and in particular in light of the current public health restrictions. He underlined that the work of the working groups is now over, and that it is henceforth the responsibility of the CAHAI to finalise the document before transmitting it to the Committee of Ministers.
