# REPORT OF THE 17<sup>TH</sup> CAHROM BUREAU MEETING

# Paris, 14 February 2019

#### **OPENING OF THE MEETING AND ADOPTION OF THE AGENDA**

- 1. Ms Tatjana ANĐELIĆ, Chair of CAHROM (Montenegro), **opened the meeting**. Apologises were noted from Ms Merita Xhafaj (Albania), who fell ill and had to cancel her participation. The list of participants is set out in the Appendix to his Report.
- 2. The **agenda of the 17<sup>th</sup> CAHROM Bureau meeting** [document CAHROM (2019)2prov] was adopted.

# DRAFT AGENDA OF THE 17<sup>th</sup> CAHROM MEETING, TOULOUSE, FRANCE, 11-14 June 2019

- 3. Mr Thorsten AFFLERBACH, Head of Division for the Roma and Travellers Team, introduced the draft annotated agenda of the 17<sup>th</sup> CAHROM meeting in Toulouse.
- **4.** Mr Manuel DEMOUGEOT, CAHROM member of France and Director of the Inter-ministerial Delegate to Accommodation and Access to Housing (DIHAL), one of the co-organisers together with the municipality of Toulouse, of the 17<sup>h</sup> CAHROM plenary meeting, **informed the Bureau about the proposed arrangements and logistics**, **suggested a few modifications in the agenda**, in particular in relation to side events, indicated the participation of a number of high-level French authorities and the invitation addressed to the Deputy Secretary General of the Council of Europe, Ms Gabriela BATTAINI-DRAGONI<sup>1</sup>.
- 5. The Bureau **adopted the revised draft annotated agenda of the 17<sup>th</sup> CAHROM meeting** [document CAHROM (2019)4prov] and **decided to transmit** it to all CAHROM members, participants, and observers together with the convocation letters.
- 6. The Bureau **agreed to invite as** *ad hoc* **speakers** at the Toulouse meeting, Ms Mirjam KAROLY, consultant of the CAHROM drafting group, to present the draft Committee of Ministers' recommendation on the inclusion of Roma and/or Travellers' history in school curricula and teaching materials. With a view to agenda item 11, the Bureau **also agreed** to invite Mr Miguel

CAMACHO-COLLADOS, Head of Unit in the National Bureau for Hate Crimes under the Spanish State Secretary for Security, Coordination and Studies, to present improvements in data collection related to hate crimes and anti-Gypsyism in Spain, Ms Carmen SANTIAGO-REYES, Lawyer and President of the Association of Spanish Gypsy Women KAMIRA, to present the mobile application to report online crimes motivated by hate, discrimination and anti-Gypsyism, as well as one or two speakers from the United Kingdom to provide the Committee with information on the "True Vision" online hate crime reporting portal, on the Traveller Movement's #OperationReportHate project and on the working group established by the Inter-Parliamentary Coalition for Combating Antisemitism online and Cyberhate.

#### RECENT DEVELOPMENTS

- 7. Mr Thorsten AFFLERBACH, Head of Division for the Roma and Travellers Team, presented recent developments at the Council of Europe, including the financial situation of the Organisation and its possible impact on CAHROM meetings and work programme. He informed the Bureau about the adoption the Abridged report of the 16th CAHROM meeting by the GR-SOC at its 17 January 2019 meeting and about the postponement of decisions concerning the request from the Sovereign Order of Malta and from the European Roma Institute for Arts and Culture (ERIAC) to be granted "participant" and "observer" status in CAHROM, respectively. Mr Afflerbach also provided information regarding the plans for the drafting of and consultation on a post-2019 strategic policy document on Roma and Traveller inclusion and informed the Bureau that the report of the 6<sup>th</sup> Dialogue meeting with Roma and Traveller civil society, which assessed the implementation of the current Thematic Action Plan on the Inclusion of Roma and Travellers (2016-2019) (hereafter TAP) in Strasbourg on 15-16 October 2018, was now available.
- 8. Mr Michaël GUET, CAHROM Secretary, **provided the Bureau with an update** on the external evaluation of inter-governmental committees and on major recent and upcoming activities under the TAP. He **indicated** that there would be a relatively large turnover of members at the next CAHROM meeting since Georgia, Hungary, Ireland and the United Kingdom have recently appointed new members and the Czech Republic, Germany, Greece and Spain were expected to do so in the near future.
- 9. The Bureau **took note** of recent developments at the Council of Europe, of the report of the 6<sup>th</sup> Dialogue meeting with Roma and Traveller civil society (Strasbourg, 15-16 October 2018), of the draft agenda for the 7<sup>th</sup> International Roma Women's Conference organised under the Finnish Presidency of the Committee of Ministers of the Council of Europe in Espoo, Finland, on 25-27 March 2019, and of the new Roma and Travellers portal and the new CAHROM public website.
- 10. The Bureau **took note of the fact** that, as of 14 February 2019, the country name "North Macedonia" can be used officially in the Council of Europe and CAHROM documents.
- 11. Ms Tatjana ANĐELIĆ **updated** the Vice-Chair and the Secretariat about recent developments in Montenegro, in particular in relation to the selection process and funding of Roma projects following a call for proposals, whilst Mr Ján HERO **provided information** on recent developments in the Slovak Republic, in particular in relation to history teaching and the recent visit of the EU Commissioner for Justice, Consumers and Gender Equality, who addressed Roma education issues.

# WORKING METHODS, CAHROM THEMATIC GROUPS FOR 2019-2021 AND OTHER BUSINESS

12. **The Bureau took note** of the Updated information document on the CAHROM [document CAHROM (2019)6], of the Updated list of CAHROM members and substitutes, Bureau members, rapporteurs and substitutes, and international observers and participants [document CAHROM

(2019)8], of the Updated guidelines for CAHROM rapporteurs and their substitutes [document CAHROM (2019)7] and of the Updated Guidelines for Bureau members and hosting countries on thematic visits [document CAHROM (2019)9] and **decided** to publish them on the CAHROM website and circulate them for information to members, observers and participants prior to the next CAHROM meeting.

- 13. **The Bureau took note** of the status of reports of previous thematic visits and that contributions were still expected from some experts/CAHROM members to finalise the reports of last year's thematic visits. The Bureau **invited the Secretariat to send a reminder** to the CAHROM members concerned. The Bureau **took note** of the background document for the CAHROM thematic visit on governmental support for the promotion of Romani arts and culture and Roma Holocaust remembrance, as well as related international cooperation to be held in Berlin, Germany, on 20-22 February 2019 [document CAHROM (2019)4prov].
- 14. The Bureau **took note** that three thematic visits were already scheduled to take place before the summer, i.e. Germany (Berlin, 20-22 February 2019), Croatia (Osijek, 8-10 May 2019) and Ukraine (Kharkiv, 24-26 June 2019) and that the list of partner countries was complete, with a few countries on a waiting list in case there are last minute cancellations. The Bureau **took note of the fact** that Norway, Sweden and the United Kingdom had withdrawn from the thematic visit to Germany but would be ready to contribute to the thematic report. The Bureau **took note** of the statistics concerning member states' participation in CAHROM thematic visits, which have been updated to include the above information [document CAHROM (2019)1Add].
- 15. The Bureau took note of the fact that the thematic visit in the United Kingdom, initially scheduled in spring, had been postponed to the autumn, due to the BREXIT. Having in mind that there are six proposed thematic visits in 2019, whilst the budget available is only for a maximum of five per year, bearing also in mind that, due to the financial crisis, the budget available for CAHROM thematic visits might be reduced for the second part of the year, and pending the development of relations between the Russian Federation and the Council of Europe, the Bureau decided to give priority to scheduling thematic visits to the United Kingdom on inclusive education, then to Finland on health-related issues and then to the Russian Federation on Romani culture and traditions. The Bureau recommended reviewing this priority order at the forthcoming CAHROM meeting in Toulouse, taking into consideration any possible financial and political developments. The Bureau considered that the proposed thematic groups for 2020 and 2021 should be re-examined at the next CAHROM meeting for the same reasons.
- 16. With those amendments reflected, the Bureau **endorsed** the updated list of CAHROM thematic groups/visits for 2019-2021 [document CAHROM (2019)1] and **decided to transmit** it to CAHROM members, participants and observers for information and/or completion of missing information and/or confirmations still needed from respective CAHROM members.
- 17. The Bureau **took note** of the third version of the draft CM recommendation on the inclusion of Roma and/or Travellers' history in school curricula and pedagogical materials [document CAHROM (2018)26prov3] which would be further discussed at the third drafting group meeting to be held in Paris on 15 February 2019, in the presence of the Bureau members.
- 18. Mr Michaël GUET, CAHROM Secretary, introduced the calendar of 2019 activities and highlighted those events that would request the presence of CAHROM Bureau members or CAHROM rapporteurs.

- 19. The Bureau took note of these events and decided the following:
  - Ms Merita XHAFAJ (third Bureau member, Albania) would participate in the 34<sup>th</sup> GRETA plenary meeting in Strasbourg on **18-22 March 2019** and present the work of CAHROM on human trafficking issues within Roma communities<sup>2</sup>;
  - Mr Ján HERO (Vice Chair, Slovak Republic) would represent the CAHROM at the CDPPE meeting in Strasbourg on **20 March 2019** and present the 4<sup>th</sup> version of the draft CM recommendation on the inclusion of Roma and/or Travellers' history in school curricula and pedagogical materials [document CAHROM (2018)26prov3];
  - Ms Tatjana ANĐELIĆ (Chair, Montenegro) would represent the CAHROM at the 7<sup>th</sup> International Roma Women's Conference in Espoo, Finland, on **25-27 March 2019**. The CAHROM Rapporteur on Gender Equality (Ms Mabera KAMBERI, North Macedonia) would also attend this Conference. They would be invited to stay over for the Gender Equality Conference "Rising to the challenge of sexist stereotypes", organised in Helsinki on **28-29 March 2019** under the Finnish CM Presidency;
  - Ms Tatjana ANĐELIĆ (Chair, Montenegro) and Ms Merita XHAFAJ (third Bureau member, Albania) would be invited to the 7th meeting of the Council of Europe Dialogue with Roma and Traveller civil society to be held in Strasbourg on 11-12 April 2019, which will address the protection of family life by securing housing and preventing evictions (provisional title);
  - Mr Ján HERO (Vice Chair, Slovak Republic) would represent the CAHROM at the 6<sup>th</sup> OPRE meeting (CoE/FRA/ENNRI/Equinet Operational Platform on Roma Equality) to be held in Bratislava on 14-16 May 2019. The CAHROM Rapporteur on anti-Gypsyism and hate crime (Mr Andrès ZANZI from Sweden) or his substitute (Mr William HANNAM from the United Kingdom) may also be invited, subject to the availability of budgetary resources;
  - The CAHROM Roma Children Rapporteur (Ms Henna HUTTU, Finland) <u>or</u> her substitute (Ms Sophie HEEGARD-SCHROETER, Switzerland) could be invited to the CAHENF meeting in Strasbourg on **21-22 May 2019**, if there was a need;
  - The CAHROM Rapporteur on Gender Equality (Ms Mabera KAMBERI, North Macedonia) or her substitute (Ms Berill BARANYAI, Portugal) may be invited to the 15<sup>th</sup> Gender Equality Commission meeting in Strasbourg on 22-24 May 2019 that includes a <u>platform of independent international and regional mechanisms on violence against women and women's rights</u> and a thematic event "Women's Rights at the Crossroads: Strengthening International Co-operation to close the gap between Legal Frameworks and their Implementation".
- 20. The Chair closed the 17<sup>th</sup> CAHROM Bureau meeting.
