Since 2020, the European Day of Justice is marked in North Macedonia with public events and other activities that are organised as part of awareness raising initiative on Free Legal Aid (FLA) organised with the support of the joint EU and Council of Europe programme "Horizontal Facility for the Western Balkans and Türkiye".

## Rules and description of the photo competition

#### Applying Date: from 25th of October 2024 to 25th of November 2024.

**Rules:** Original and **creative photos** should depict the benefits and advantages that equal access to justice can bring to everyone's life. All photos should be submitted with an explanatory caption in Macedonian.

**Ages:** The competition is open to individuals, talented amateur photographers, **of all ages** from North Macedonia.

**Description:** The competition challenges contestants to capture the essence of justice through the lens of a camera. The young photographers will be evaluated on their creative interpretation of justice (**promoting human rights, justice, equality and diversity**), as well as the quality of the photos. Photographers conveying positive and empowering contexts or messages in their photos are encouraged. The photos will be also evaluated on the basis of the pertinence of their message and their artistic merits.

**Selection:** The evaluation process will be conducted by an assessment team composed by Council of Europe representatives, representatives from the team of Young European Ambassadors in North Macedonia, as well as independent professionals with relevant background in the field of photography.

**How to apply?** All you need to do is, take an authentic photo (min 6 Megapixels in .jpg format) and send it to us on the following email: DG1.FLA.NM@coe.int. You will need to include the name, surname and age of the author, and a short description/caption of the photo and the contact information. You are allowed to submit maximum three (3) photos.

# Rules and description of the drawing competition

Applying Date: from 25th of October 2024 to 25th of November 2024.

**Rules:** Original and **creative drawings/paintings** should depict the benefits and advantages that equal access to justice can bring to everyone's life. All drawings should be submitted with an explanatory caption in Macedonian.

**Ages:** The drawing competition will be open to children and young artists aged **6-18** years from North Macedonia. They will compete in two categories:

Category 1: Ages 6-12 Category 2: Ages 13-18

**Description:** The drawing competition encourages young artists to express their vision of justice, equality, fairness and human rights through their drawings. The drawings will be evaluated based on children's and youngsters' creative interpretations of **justice**, **human rights**, **equality**, **and diversity**. The technical skills and artistic quality of the drawings will be considered. Participants who convey positive and empowering messages in their artwork are particularly encouraged to participate. The drawings will be also evaluated on the basis of the pertinence of their message and their artistic merits.

Participants may use pencils, ink, charcoal, pastels, watercolors, acrylics, or any other traditional medium. However, digital and AI-generated artwork will not be accepted. Artwork must be on paper or canvas and can range in size from A4 to A2.

**Selection:** The evaluation process will be conducted by an assessment team composed by Council of Europe representatives, representatives from the team of Young European Ambassadors in North Macedonia, as well as independent professionals with relevant background.

**How to apply? -** "Submissions can be made either by delivering the physical artwork to the Council of Europe Programme Office in Skopje (Soravia Center, Filip Vtori Makedonski br. 3, 1000 Skopje) or by emailing a high-resolution scan or photograph of the artwork to DG1.FLA.NM@coe.int. Each submission must include the artist's name, surname, age, a brief description or caption of the artwork, and contact information. Participants may submit up to three (3) drawings."

## General rules for the photo and drawing competition

**Exhibition:** All qualified photos and drawings will be exhibited for the public around 10<sup>th</sup> of December to mark the International Human Rights Day (concrete dates to be confirmed). During the exhibition, the winners in all categories will be announced, and certificates awarded. The winners of the photo and drawing competition will be promoted on the Council of Europe channels, and the winning photos will be printed out as posters and disseminated in the framework of the awareness raising initiative on FLA and further utilised on the Council of Europe materials (reports/leaflets/studies).

**Intellectual Property Rights:** By submitting the Artwork, the author (parent/legal guardian to author under the age of 18) confirms that is the sole owner of the intellectual property rights over that artwork. The author confirms that they have complied with the applicable legislation in terms of obtaining the consent for the use of the photos from the persons featured in them and has the right to submit this Artwork.

By submitting the Artwork, the author (parent/legal guardian to author under the age of 18) grants to the Council of Europe a non-exclusive and free licence for the entire world and for the entire period of protection by the applicable intellectual property rights law for the use of the Artworks as follows:

- The Artworks may be exhibited in the Council of Europe and in the framework of relevant Council of Europe events, such as, but not limited to, the International Human Rights Day, in any format, to feature the participants and their respective Artworks;
- The Artworks may be used for awareness-raising purposes for the work of the Council of Europe in the form of visibility materials (brochures, posters, flyers...) and for online communication (including social media). When the Works are on display, proper reference to the authors shall be made, as well as the reference to the competition "Let's bring justice closer to the citizens".
- The Council of Europe reserves the right not to display the Artworks.

The Council of Europe shall immediately notify the author in writing giving full particulars if any of the following matters come to its attention:

- any actual, suspected or threatened infringement of the intellectual property rights; or
- any claim made or threatened that the Works infringe the rights of any third party; or

- any other form of attack, charge or claim to which the intellectual property rights may be subject. In respect of these matters:

- -the author shall, at their absolute discretion, decide what action to take, if any;
- -the author shall have exclusive control over, and conduct of, all claims and proceedings;
- -the Council of Europe shall not make any admissions other than to the author and shall provide the author with all assistance that the author may reasonably require in the conduct of any claims or proceedings; and
- -the author shall bear the cost of any proceedings and shall be entitled to retain all sums recovered in any action for his own account.

**Data protection rights**: Processing of author's personal data is governed by the <u>Council of Europe Regulations on the</u> <u>Protection of Personal Data</u> adopted by the Committee of Ministers on 15 June 2022.
