As a MP in the National Parliament in Serbia, in two terms, I have executed various positions, representing Republic of Serbia in International bodies. I was a member of the delegation of the National Assembly in the **Parliamentary Assembly of the Mediterranean**, and presided the Standing Committee on Dialogue among Civilisations and Human Rights and served as the Vice-President of the Parliamentary Assembly of the Mediterranean. Since 2020, I am elected representative of the **Joint Consultative Committee (JCC)** of Serbia and EU.

In the National Assembly I participated in the work of the Committee on Labour, Social Issues, Social Inclusion and Poverty Reduction, Committee on the Diaspora and Serbs in the Region, Committee on Culture and Information. Right now, in the Regional Assembly of the AP Vojvodina I am a member of the Committee for European integration, Administrative issues and Green and Environmental Network of parliamentarians.

Sincerely hope that I will have your support in a race for the Vice-president of the Chamber of Regions in the Congress.
