Recital 71 AVMSD (2010)

Criteria for defining producers who are independent of broadcasters:

- The ownership of the production company,
- The amount of programmes supplied to the same broadcaster, and
- The ownership of secondary rights.



Definition of independent producer in national legislation



Definition



Criteria for defining producers who are independent of broadcasters:

- ✓ The amount of shares an AVMS provider holds in a production company (or vice versa);
- The level of turnover a producer generates from contracts with a single AVMS provider (e.g. the quantity of programmes supplied).

Definition of independence as pre-condition for funding and quota benefits

Why is the definition of independent production important?

Because it determines who is the subject of certain rights and support measures.





AVMS Directive



Promotion of independent European works under the AVMS Directive

Article 17 AVMSD



Quota obligation for either the **transmission time** or the **programming budget** for the promotion of European works created by **producers who are independent of broadcasters.**



Financial investment obligation on broadcasters

- Works by independent producers
- Other specific criteria

Works by independent producers only BE (VL), ES, NL, SE, SI

Both European works and independent works FR. IT

Independent production and works of national original expression DK

National and European "creative" works
PT

National works and independent production CH




Works by national authors and audiovisual works completed with the financial support of the State EE

> National cinematographic works GR, HU, LV



Financial investment obligation on broadcasters – Art. 17 AVMSD

- Mandatory (both PSB and commercial)
- Mandatory (only PSB)
- Optional (or quota or levy)
- National/linguistic works
- No obligation



Financial obligations on VOD services – Art. 13 AVMSD

- Investment in independent productions
- General mandatory investment
- Optional (or quota or levy)
- General obligation
- No obligation



Quota obligation on broadcasters to promote works by independent producers – Art. 17 AVMSD

A 10% minimum share imposed by AVMS Directive

- Mandatory
- Optional
- No obligation



Direct and indirect public funding for independent production

Selective and/or automatic support for independent producers at national and regional levels:

- As a precondition (e.g. Denmark and Portugal)
- Usually for certain schemes



Interprofessional agreements

Obligations concerning the support of independent production may be attached to broadcasters' licences.

Promotion of independent producers by PSBs

- Public mission to promote diversity and unbiased information
- Market importance
- Being publicly financed
