- 1. With a note dated May 19, 2025, the European Committee of Social Rights asked the Parties involved to provide any new factual information about the current situation of the land in Via Carrafiello.
- 2. In compliance with this request, the Italian Government inform that the eviction order was not enforced because the occupants voluntarily left the land in question in compliance with the court order.
- 3. This circumstance made the intervention of the police unnecessary.
- 4. In particular, on 28 April 2025, the Judicial Officer accessed the land located in Via Carafiello with the assistance of the police in order to enforce the eviction order issued by the Civil Court of Naples R.G. no. 3547-1/2024.
- 5. On that occasion, the Judicial Officer ascertained that the land owned by Mr. Micillo Antonio was free from people: it was clear that the occupiers, spontaneously executing the eviction order, abandoned the previously occupied areas.
- 6. This implies the loss of interest in the decision on the collective complaint, lodged by the Complainants with the aim of preventing the enforcement of the eviction order.
- 7. Having clarified the state of progress of the forced eviction procedure ordered by the Court of Naples, it should be noted, for the sake of completeness, that the Italian Government acted with the aim of protecting Mr Micillo's property, while also ensuring adequate protection of the interests of the Romani families involved.
- 8. The Municipality of Giugliano, also in order to avoid prejudice to the minors involved, has identified housing solutions to be made available to the community affected by the eviction proceedings; however, the allocation process has not been completed for reasons not attributable to the Administration.
- 9. In particular, the Municipality of Giugliano has taken steps to ensure the schooling of minors and to identify accommodation to be made available to Romani families, relying on funds from the "A.b.r.a.m.o" project, approved by the Campania Region, for which an initial allocation of € 864,000 has been made.

- 10. In addition, a property confiscated from organised crime, located in Palmentiello, was identified and renovated.
- 11. The Municipality then issued a call for applications for the temporary allocation of housing, to be formalised through free loan agreements.
- 12. Only six families applied.
- 13. Representatives of the social organisation (so called "terzo settore") therefore began furnishing the apartments, but on 5 July 2024 they returned the keys to the Municipality because the families had decided not to take up the housing solution.
- 14. Subsequently, following a new meeting held on 31 July 2024 at the Prefecture, the Municipality published a new call for applications for the allocation of housing to other families comprising a total of 28 people.
- 15. However, given the criminal records of those concerned, it was not possible to proceed with the allocation.
- 16. Despite these difficulties, the local authorities are continuing with the preliminary activities relating to the MA.REA. project already launched by the Association 21 luglio ETS.
- 17. The project consists of six phases aimed at definitively overcoming the Roma camp.
- 18. In this first phase, lasting three months (phase 1, called "La Comunità Locale"), a coordinator will be appointed to oversee the removal of the settlement; in addition, a listening campaign will be conducted to identify leaders within the Roma camp, stakeholders active in the area will be mapped and a Local Action Group will be established by municipal resolution at the end of the three months.
- 19. In order to ensure the proper integration of these families, steps are being taken to relocate an entire family of about forty people to a municipal property in Palmentiello, consisting of six apartments for specific use.
- 20. Discussions are also underway with the Italian State Railways for the free acquisition of four more flats in the *Giugliano in Campania railway station* area to house about twenty-five people.
