MEETING REPORT

I. OPENING OF THE MEETING AND WELCOME

1. The meeting was opened by the Chair of the CDCJ, Mr João Arsénio de Oliveira (Portugal), and the Chair of the CDENF, Ms Maria-Andriani Kostopoulou (Greece), who welcomed the participants.

II. ADOPTION OF THE DRAFT AGENDA AND ORDER OF BUSINESS

2. The agenda was adopted as set out in Appendix I. The list of participants appears in Appendix II.

III. STATEMENT BY THE CHAIR AND THE SECRETARIAT

- 3. Mr Seamus Carroll, Chair of the CJ/ENF-ISE, informed the Bureaus on the progress made by the Committee of experts and on the outcome of its 3rd meeting (14-15 April 2021), commending the two feasibility studies as an excellent foundation on which to base the further work of the Committee. The Bureaus took note of the report of the third meeting of the CJ/ENF-ISE (document CJ/ENF-ISE(2021)PV1) and welcomed the progress made.
- 4. The Secretariat informed the Bureaus about the outcome of the Regional Discussion on "Children's rights and alternative care" organised by the CDENF Secretariat under the auspices of the Hungarian Presidency of the Committee of Ministers (1 June 2021). Participants highlighted the question of state responsibilities in relation to safeguarding the rights of the child in cross-border alternative care situations, as raised during one of the sessions, as an important and challenging issue that would merit further consideration.
- 5. The Bureaus also took note of the information provided on the state of play in the preparation of the upcoming Strategy for the Rights of the Child (2022-2027) to be approved by the CDENF at its fourth Plenary meeting (October 2021) in view of its adoption by the Committee of Ministers in early 2022, in which the work of the Committee of Experts would be very relevant, notably, under the two priority areas relating to equal opportunities for all children and child-friendly justice.

IV. FEASIBILITY STUDIES ON THE PROTECTION OF THE BEST INTEREST OF THE CHILD AND THEIR RIGHTS IN SITUATIONS OF PARENTAL SEPARATION AND IN CARE PROCEEDINGS

- 6. Following an introduction by the Chairs of the CDCJ and of the CJ/ENF-ISE, the Bureaus examined the two feasibility studies (documents CJ/ENF-ISE(2021)08A and CJ/ENF-ISE(2021)08B), commending the quality of the work and congratulating the consultants and the CJ/ENF-ISE on the progress achieved.
- 7. The Bureau members agreed that the work forward should focus on elaborating practical guidance and on promoting good practices relating to best interests determination in administrative and court proceedings rather than attempting to achieve harmonisation between the different national legal concepts.

The outcome of the work should guide member states to uphold the international standards set out in the UNCRC and the ECHR, as developed in the substantial body of case-law of the ECtHR; and in other international instruments in a practical context. This would also pave the way towards promoting good practices in the so-far less explored area of protecting the best interests of the child in situations of parental separation.

- 8. The Bureau members further considered that this purpose would be best achieved in the legal form of a recommendation, accompanied by an explanatory report and to be complemented at a later stage by implementing tools, such as practical handbooks or other texts.
- 9. Participants exchanged views on whether it would be more appropriate to address both situations (parental separation and care situations) in one single instrument, or to divide the work into two separate instruments. Some members expressed a clear preference for a single instrument, while others considered that there is merit in having two separate instruments, considering the specificities of the two subject matters and different target groups to be addressed.
- 10. The Bureaus took note of the preference expressed by the CJ/ENF-ISE and its Chair towards the development of a single instrument in the form of a recommendation with guidance on both parental separation situations and care proceedings, and the consideration that it would still be possible to separate the draft text into two separate instruments at a later stage of the drafting process if necessary. The Bureaus agreed that the work should be initiated under the assumption of developing a single policy instrument, which would cover in a comprehensive manner aspects common to both subject matters as well as the aspects which only apply to one of the two areas, while ensuring utmost clarity with respect to measures applicable to different professionals concerned. It was agreed that the Bureaus would be kept appraised of progress in this respect, as well as any considerations that may require to revisit the CJ/ENF-ISE's deliverables and workplan.
- 11. The Bureaus adopted the two feasibilities studies and agreed on their publication after final editorial revisions to be carried out by the Secretariat.

V. Composition of CJ/ENF-ISE

12. The Bureau members examined the f six nominations received for the two vacant positions of the CJ/ENF ISE, taking into account, notably, any previous participation in the Committee of Experts' work, the professional qualifications of the candidates and the specific profile of expertise best complementing the expertise already available within the Committee, as well as geographic and gender considerations. The Bureaus agreed by consensus to propose Mr. Thomas Knoll-Biermann (Germany) and Dr. Salomé Adroher Biosca (Spain) as additional members of the expert group.

VI. <u>Preparation of the new Programme and Budget (2022-2025), CJ/ENF-ISE proposals for future terms of reference, working methods and work plan</u>

13. The Bureaus took note of the update provided by the Secretariat on the process of finalisation of the draft terms of reference for the CJ/ENF-ISE in the Programme and Budget (2022-2025) and rules applicable for working methods as of January 2022.

14. The Bureaus examined and agreed on the updated working methods and workplan for the CJ/ENF-ISE for 2021 and tentatively for 2022/2023 subject to the adoption by the Committee of Ministers of new terms of reference for the CJ/ENF-ISE (document CJ/ENF-ISE(2021)01Rev3, restricted). Particular attention was drawn on the need to ensure, through CJ/ENF-ISE working methods, an inclusive participation and consultation of a broad range of stakeholders, including children.

VII. ANY OTHER BUSINESS

15. No other issues were raised.

VIII. APPROVAL OF THE JOINT MEETING REPORT

16. The Bureau members agreed that the approval of the report of the meeting would be undertaken through a written procedure after the meeting.
