**Towards a pan-European legal instrument
to codify the rules of European drama series co-production**

I. Scope

The Steering Committee for Culture, Heritage and Landscape (CDCPP) under the terms of (ii)c, (vii) of the Draft Programme and Budget 2022-2025, following deliverable 11 of the Terms of Reference of Intergovernmental Structures (ToR) **is to decide the establishment of an expert working group under CDCPP** authority reporting on the creation of a legal mechanism to support European drama series production. **The objective is to assess and possibly create a legal instrument to codify the rules of drama series co-production, eventually structured as a convention.**

II. Background

In view of the role of the CDCPP in "Promoting policy measures on the digitisation of culture, cultural heritage and the audiovisual sector in view of protecting their diversity and meeting the challenges and opportunities of artificial intelligence in this sector and help share best practices", Eurimages submitted in June 2021 a document for information. Its purpose was to describe the importance of the drama series format in the audiovisual landscape, its implications, and the possible fields of action for the Council of Europe and Eurimages.

Under the auspices of the Hungarian Presidency of the Council of Europe, a conference on "Preserving Independent Production, Diversity and Pluralism in Drama Series in Europe: Can International Cooperation be Part of the Solution?" was held in Budapest, on September 30th – October 1st, 2021.

The event, organised by Eurimages, together with the Hungarian National Film Institute and the Ministry of Foreign Affairs and Trade of Hungary, was framed as a brainstorming session among industry professionals such as producers, distributors, broadcasters, and national film fund representatives. The participants exchanged on the most urgent needs if high-end series production in a highly competitive market dominated by non-European players were to be facilitated.

The aim was to explore further the possibility of creating a new legal and/or financial instrument to ease the international co-production of drama series. This exploration builds on the recommendation made in 2018 by the external evaluation of Eurimages. In response to this recommendation, Eurimages commissioned a Study¹ in 2019 from an independent consultant to better understand the changing environment created by the emergence of VoD platforms and the use of AI in the distribution of audiovisual content.

Acknowledging the groundwork carried out during this conference and the future steps to be taken during successive presidencies of the Committee of Ministers, the Hungarian authorities named this initiative "The Budapest Drama Series Process."

The participants' conclusions² confirm the importance of the role of the Council of Europe in preserving cultural diversity and pluralism in the audiovisual sector. They also highlight the necessity of international co-productions to offset the fragmentation of the European audiovisual market, especially for smaller countries with limited financial means. Creative and technical co-operation amongst professionals from different countries also positively affects the quality and originality of drama series. They underlined the need to codify the rules of drama series co-production through a legal instrument, similar to the Convention on Cinematographic Co-production. **Such a tool would make the market more transparent and allow independent producers to protect their rights – including their Intellectual Property – in negotiations with broadcasters or global platforms.**

A financial tool is necessary, participants believed, to cover part of the higher budgets required at critical moments of the production chain: either for story development, at the beginning of the project, or for closing the production financing (the last 15-20 per cent); in addition, and complementary to the legal instrument.

The rapid developments within the sector govern the urgency of such measures. In 2021, Netflix became the most significant single commissioner of new European scripted content, according to a study³ conducted by Ampere Analysis, and as such, for the first time, a non-European company takes the lead ahead of major European public and private broadcasters. The same company is forecast⁴ to spend more on original programming than ever before, splitting its global content budget almost evenly between that and acquisition costs. In four years, 46.5% of the streaming giant's projected \$18.92 billion budget will go toward original content, compared with 37.8% in 2020. Content acquisition costs will remain a dwindling majority of Netflix's budget, shrinking from 62.2% in 2020 to 53.5% in 2025. **Such forecasts are a clear sign of the pressure on independent producers to provide production services instead of creating their own content.**

Eurimages, following the industry's call for action summarised in the Budapest conclusion paper and taking into consideration the studies undertaken until now, is proposing two distinct yet complementary actions:

1. A **legal instrument** to codify the rules of drama series co-production, expected to be structured as a convention.
2. A **financial support programme** that aims to cover the needs of the independent producers by strengthening their position when negotiating with the big non-European platforms.

Considering the scope of the activity covered by the CDCPP, this paper will address further aspects related only to the legal instrument.

With this in mind, the legal instrument should create a standard use of the term 'co-production in the context of drama series, reflecting the following principles: shared intellectual property, shared responsibility, and shared financial and above all creative contributions. Further, the legal instrument should also facilitate bridging the different legal approaches to co-operation in the drama sector and emphasise the relevance of national film agencies and public broadcasters. As such, the legal instrument aims to provide an independent framework to the parties involved, allowing independent producers and creators to retain intellectual property and find themselves in a balanced co-operation with more commercially driven partners. Such measures will enable the producers and creators to provide higher cultural service to society, diverse and independent.

In parallel to the legal instrument dedicated development process, Eurimages will further explore options and viable models for a financial support programme. In the first phase, Eurimages, with its extensive experience in financing European co-production and with the support of an expert working group under its authority, will develop a proposal for a pilot support scheme that could be further administrated by the fund.

III. CPPWG-Series – Expert working group for the creation of a legal instrument to codify the rules of drama series co-production (Term of Reference – [Appendix 2](#))

Meeting the challenges and opportunities of digitisation and artificial intelligence in the sector, the CDCPP promotes policy measures on the digitisation of culture, cultural heritage and the audiovisual industry in view of protecting their diversity. In that perspective, the **CDCPP decides to establish, under its authority, an expert working group further referred to as CPPWG-Series.**

III.1 Mission

Under the supervision of the Steering Committee for Culture, Cultural Heritage and Landscape (CDCPP), the CPPWG-SERIES is entrusted with the task of assessing the possible creation of a legal instrument to support European drama series, and if appropriate drawing up such an instrument, possibly in the form of a convention which considers recent technological and financial changes in the European film and drama sector.

III.2 Professional profile of the experts who will sit on the CPPWG-SERIES

To select the experts who will sit on the CPPWG-SERIES, the Eurimages Secretariat has drafted the following profile to guide Member States in identifying appropriate experts.

Required professional profile:

- a. with experience in the drama series sector and preferably with knowledge in implementing the European Convention on Cinematographic Co-Production;
- b. a thorough knowledge of procedures, legal aspects, mechanisms, and policies in co-production at national, European and international levels;
- c. with solid experience in international relations.

The composition of the working group will reflect a geographical and gender balanced representation of the Council of Europe's member states.

III.3 Procedure for the selection of the experts sitting in the working group.

The Secretariat will forward to the CDCPP Bureau the proposed working group composition based on the member states' proposals.

Once the CDCPP Bureau members have selected up to 15 experts, the Secretariat will confirm the selection with the CDCPP and provide details concerning the work expected from them, who will sit in the working group and the provisional schedule, financial and logistical aspects of the three meetings taking place in 2022/23.

- welcome the conclusions of this meeting, including the need to codify the rules of drama series co-production through a legal instrument similar to the Convention on Cinematographic Co-Production;
- decide to establish an expert working group (CPPWG-Series), assessing the possible creation of a legal instrument to support European drama series, and if appropriate drawing up such an instrument, possibly in the form of a Convention which considers recent technological and financial changes in the European film and drama sector;
- request its Bureau to select up to 15 experts for the working group;
- support the proposal to find political consensus through a ministerial declaration at the Council of Europe Conference of Ministers of Culture, under the auspices of the Italian Presidency of the Council of Europe.
