# STEERING COMMITTEE ON DEMOCRACY (CDDEM)

#### **MEETING REPORT**

2nd Plenary meeting (29-30 October 2024)

Strasbourg, Palais de l'Europe · Room 11 (and online via KUDO)

The Steering Committee on Democracy (CDDEM) held its 2nd plenary meeting in Strasbourg and online on 29-30 October 2024, with Mr Thomas Zandstra (Netherlands) in the Chair. Vice-Chair Mr Vebjørn Heines (Norway) chaired the afternoon session of the meeting on 30 October. Mr Matjaž Gruden (Director for Democracy) facilitated the meeting with the agreement of the Committee until after the election of Chair and Vice-Chair during the afternoon session on 29 October.

#### 1. Opening of the meeting

Mr Matjaž Gruden, Director for Democracy, opened the meeting and welcomed all participants<sup>1</sup>, the list of which appears in Appendix II below.

#### 2. Adoption of the agenda and order of business

The CDDEM reviewed the draft agenda and adopted it without changes. The agenda appears in Appendix I below. Together with the abridged and full meeting reports, the agenda is also available on the CDDEM's website.

The Committee agreed on a provisional arrangement for the Secretariat, represented by Mr Gruden, to facilitate the first session of the meeting pending the election of CDDEM Chair and Vice-Chair during the afternoon session on 29 October (see section 8 below).

#### 3. Statement of the Secretariat

The acting Chair updated the CDDEM members on relevant recent developments within the Council of Europe, notably that a new Secretary General, Mr Alain BERSET, assumed position on 18 September 2024. Mr Berset's priorities include supporting and facilitating the recovery of a free, reconstructed Ukraine, the implementation of the commitments made at the Council of Europe's 2023 Summit of Heads of State and Government and of the Reykjavík Principles for Democracy. A Council of Europe action plan on democracy is to be elaborated to provide a forward-looking outlook for the Organisation, focussing on pressing and emerging challenges and strengthening the Organisation's role in responsible global governance.

The acting Chair further informed the CDDEM about the operation of the Register of Damage for Ukraine established at the Reykjavík Summit in 2023; the adoption of the Framework Convention on Artificial Intelligence and Human Rights, Democracy and the Rule of Law (CETS No. 225), now open for signature, and about the preparation of the new transversal Youth Perspective resulting from the Reykjavík Summit, which is to be integrated in the work of the Council of Europe's intergovernmental committees.

#### 4. Tour de table

(New) representatives of Bulgaria, Croatia, Latvia, Malta, Poland, San Marino, and Slovakia have joined the CDDEM since its 1st plenary meeting on 13-14 May 2024. After being welcomed to the Committee, the newly joined members outlined their governments' priorities and ongoing activities in the area of democracy. Several of them emphasised the importance of the Reykjavík agenda and the Rs to be articulated and promoted by the Committee.

# 5. Standard setting: Parameters to facilitate the application and implementation of the Reykjavik Principles for Democracy

The acting Chair provided an update on the work carried out by the CDDEM's Working Group on Parameters for the application and implementation of the Reykjavík Principles of Democracy (GT-P). The GT-P held its first meeting in September 2024, and a second meeting was in preparation for December this year, where the draft Parameters will be further discussed and revised following comments by the CDDEM as well as other relevant Council of Europe sectors and entities. The acting Chair further informed the CDDEM that the Secretariat would also consult with independent academic experts and practitioners from relevant organisations on ways for the Parameters to achieve optimal practical value for member states and other stakeholders. This process is to ensure the best possible quality of the document. He further alerted the Committee to the importance of consulting with wider civil society on the development and implementation of the text.

# 5.1. Exchange of views with Marin Mrčela, President of GRECO (Group of States against Corruption) (online)

The CDDEM held an exchange with Mr Marin Mrčela, President of the Group of States against Corruption (GRECO), who presented GRECO's history, working methods and ongoing activities. Mr Mrčela stressed that, while GRECO recommendations to member states reflect their particular contexts, the central building blocks in fighting corruption in the public sector are universal. Specifically on the interplay between democracy and the corruption prevention, he highlighted the importance of transparency and political integrity, underlining that non-transparent, illicit influences on democratic processes, including through financing, may put into question the legitimacy of state institutions and can lead to the loss of trust in politics and low voter turnout. Good governance and anti-corruption go hand in hand, thus the overall trend is to perceive corruption not in isolation, but as being a fully transversal issue, to which the response also has to be multi-faceted, lauding the CDDEM's integrative approach in the work on Parameters in this regard.

CDDEM members then exchanged views with Mr Mrčela on the importance of anti-corruption measures for the promotion and protection of democracy throughout Europe, and concretely for the application and implementation of the Reykjavík agenda. Asked about the focus of the parameters dealing with the prevention and fight against corruption, Mr Mrčela pointed to the importance of effectively capturing the triad of transparency, monitoring and sanctions in the text of the Parameters.

#### 5.2. Examination of the first draft of the Parameters

In the introduction, it was briefly restated that the Parameters aim to promote a shared understanding of European democracy, protect it against erosion and provide a solid foundation for policy reforms in member states and (self-)assessment of the state of their democracies. The acting Chair presented some of the conclusions from the 1st meeting of the GT-P in September, such as the requirement that the Parameters be both concrete enough to reflect the European and international democratic standards and principles, and abstract enough to accommodate member states' national contexts and diverse democratic systems. The document should be a practical tool, accessible for use by member states and potential other stakeholders. In this connection, the acting Chair reiterated that a development of further monitoring mechanisms to oversee the application of the Parameters was not envisioned at the level of the Council of Europe.

The CDDEM reviewed the structure, content and language of the draft Parameters. Members stressed the need for clarity on who the document is addressed to and how it should be used. Some suggested that the central role of member states and their governments in this regard should be made more explicit. Several members argued that the Parameters should also be made available for use by other actors, such as the media, researchers and civil society. Furthermore, members put forward several ideas, such as to include a procedural aspect into the document, highlighting the need to establish a support and experience-sharing mechanism, to exploit the Parameters as a benchmarking tool similar to that established for the <a href="European Label of Governance Excellence">European Label of Governance Excellence</a> (ELoGE). The question of monitoring the application of the Parameters was raised several times, with some member states arguing that developing further monitoring bodies and/or mechanisms would be unwise, given also the administrative burden on member states, yet others pointing to the intrinsic monitoring function of such a document.

Several members also pointed to the need to further mainstream transversal issues such as gender in the different sections of the draft Parameters. As for aspects to be further articulated in the document, there was mention of the structure and democratic functioning of political parties, ownership of Al and digital platforms, as well as wealth distribution and influence as translating into unequal shares in power distribution. The issues of democratic security, education for democracy, and the fostering of a culture of democracy more generally were also mentioned. The Secretariat further informed the CDDEM about the work currently being done to future-proof the Parameters and provide clarity on the possible uses and users of the document.

#### 6. Information from the gender equality rapporteur (GER)

Mr Edwin Lefebre (Belgium), CDDEM Gender equality rapporteur (GER), highlighted the efforts undertaken to mainstream the gender equality perspective in the work on the different deliverables that were prepared or in preparation by the Committee, and in this regard highlighted the need to see the empowerment of women and girls as much broader than protection against violence and harassment. He informed the CDDEM that he would report back from a workshop for GERs organised by the Gender Equality Division secretariat.

The acting Chair recalled that other mainstreamed perspectives championed across the Organisation ought to be given due account in the preparation of the Committee's documents, and some members expressed their views as to the importance of including mention of vulnerable groups in coming reports, or of mainstreaming equality in a broad and inter-sectional sense.

### 7. World Forum for Democracy – synergies and opportunities for introducing its conclusions into the CDDEM work

The acting Chair informed the Committee about the possible themes for the 2025 edition of the World Forum for Democracy (WFD), namely (1) "Why do we no longer like democracy?", proposing to look at the roots of the growing phenomenon of dissatisfaction with democracy; (2) "Culture and democracy", proposing to explore the links between culture, freedom of expression and political participation; (3) "Disruptive technologies and democracy", proposing to explore the risks and potentials of technological innovation for the practice of democracy; and (4) "A citizens' democracy?", proposing to explore avenues for strengthening the resilience of civil society and civic culture to the risks posed by emerging challenges.

The acting Chair reiterated that the Council of Europe's intergovernmental committees could develop a meaningful follow-up to the outcomes of the WFD, noting that synergies can be explored at this year's Forum already, as some members would be in attendance. The CDDEM then discussed the possible themes for 2025, noting in particular the topicality of the impact of digital transformation on democratic processes and the importance of strengthening civic space for a functioning democracy.

# 8. Elections of CDDEM members for the positions of Chair, Vice-Chair and members of the CDDEM Bureau and elections of members of CDDEM working groups

The Committee held elections via the KUDO online platform for the following positions: CDDEM Chair and Vice-Chair; five positions of CDDEM Bureau members and seven positions of elected members in each of the two working groups: on Parameters for the Application and Implementation of the Reykjavík Principles of Democracy (GT-P) and on Civil Society Participation (GT-CS). The candidates for election briefly introduced themselves and highlighted their respective priorities for the different positions.

The CDDEM then elected, for a one-year term of office,

Members of the GT-CS and GT-P were elected by acclamation, as there were as many candidates as there were positions to be filled.

#### Supporting member states to strengthen and maintain good democratic governance at all levels

### 9.1. Exchange of views with Mathieu Mori, Secretary General of the Congress of Local and Regional Authorities

The Committee held an exchange of views with Mr Mathieu Mori, Secretary General of the Congress of Local and Regional Authorities, who highlighted some areas of possible co-operation between the CDDEM and the Congress, namely regarding the implementation of the Reykjavík agenda. To this end, Mr Mori called on the CDDEM to develop the Parameters as a practical tool to implement this agenda, that can serve as an early warning system and ultimately secure democracy and good governance at all levels throughout Europe.

Mr Mori presented some of the areas where the Congress is taking action to implement the Reykjavík Principles, notably through the system of the European Charter of Local Self-Government, local-level election observations, the implementation of the system of the European Convention on Human rights at the local level, the European Code of conduct for all persons involved in local and regional governance, and the European Charter on the participation of young people in municipal and regional life<sup>2</sup>.

Mr Mori further updated members on the current work of the Centre of Expertise for Multilevel Governance which is implementing a number of large-scale projects in the framework of the Council of Europe's action plans for specific member states, reform agendas from the European Union, and within the Council of Europe's policy towards neighbouring regions. The project in Armenia triggered the first Rapid Response Service request with the CDDEM, and Mr Mori thanked the members for their quick and useful responses, welcoming further cooperation. Mr Niall Sheerin, Deputy Head of the Centre of Expertise, presented to the CDDEM members the European Label of Governance Excellence (ELoGE) and its recently established Accreditation Platform.

# 9.2. Appointment of a CDDEM member to the European Label of Governance Excellence (ELoGE) Accreditation Platform

The CDDEM was invited to designate a representative to the ELoGE Accreditation Platform, and to this end the Committee appointed:

Mr Georgios Chrysafis (Greece).

 CDDEM Comments to Recommendation 2281 (2024) – "Reparation and reconciliation processes to overcome past conflicts and build a common peaceful future – the question of just and equal redress" adopted by the Parliamentary Assembly of the Council of Europe (PACE)

The CDDEM finalised its comments to PACE Rec. 2281 (2024) on the basis of draft comments prepared by the Secretariat, and three member states' proposals for amendments (Belgium, Germany and Türkiye). The members concerned introduced the proposed amendments, followed by a discussion and proposals for new wording to accommodate divergent views of some member states. After further revision, the Committee reached an agreement and approved the text.

#### 11. Civil society: Strategic Lawsuits against Public Participation (SLAPPs)

The Committee welcomed the presentation of Council of Europe's recent Recommendation CM/Rec(2024)2 on countering the use of strategic lawsuits against public participation (SLAPPs) provided by Ms Giulia Lucchese, Secretary to the Committee of Experts on the Impacts of Generative Artificial Intelligence for Freedom of Expression (MSI-AI) of the Steering Committee on Media and Information Society (CDMSI), Freedom of Expression and CDSMI Division. Ms Lucchese presented the effects of SLAPPs – manifestly unfounded or abusive court proceedings – on freedom of expression and other rights of journalists and media workers, but also civil society organisations and individuals who critically address the matters of public interest. The 2024 Recommendation is characterised by a broad scope, which can usefully complement the implementation of the Directive (EU) 2024/1069 of the European Parliament and of the Council of 11 April 2024 on protecting persons who engage in public participation from manifestly unfounded claims or abusive court proceedings ("Strategic lawsuits against public participation") and the accompanying Commission Recommendation (EU) 2022/758.

Members then discussed good practices to be shared regarding anti-SLAPP strategies and efforts as well as examples of national coordination. Ms Lucchese mentioned in particular the potential of the Platform on the safety of journalists, arguing that best possible use should be made of already available mechanisms.

# 12. Guidance Note on civil society participation in the intergovernmental work of the Council of Europe

The CDDEM reviewed the draft Guidance note on civil society participation in the intergovernmental work of the Council of Europe elaborated by the GT-CS on the basis of a draft proposed by the Secretariat. The text was amended on the basis of member states' comments, as well as those provided by the secretariats of other steering committees. The Committee's comments to the final draft text were discussed one by one, resulting in minor wording amendments to accommodate different positions of certain delegations on a few individual guidelines.

The CDDEM agreed to include a provision on the possibility for civil society to participate in the work of intergovernmental committees and subsidiary bodies as part of member states' delegations, where such arrangements are deemed appropriate by an individual state. Regarding the possibility that the participation of individual civil society organisations might pose a risk to legitimate interests of member states, text was added to clarify that the rules for granting participatory status with the Council of Europe and observer status with intergovernmental committees are in place to ensure engagement in intergovernmental work only with civil society actors and organisations that respect and defend Council of Europe's core values of human rights, democracy and the rule of law. Following the review and revision of the text, the Committee reached an agreement and adopted the Guidance note.

# 13. Update of Recommendation CM/Rec(2007)14 of the Committee of Ministers to member States on the legal status of non-governmental organisations in Europe

The Committee discussed the draft Feasibility study on updating Recommendation CM/Rec(2007)14 on the legal status of non-governmental organisations in Europe prepared by Mr Jeremy McBride, President of the Expert Council on NGO Law of the Council of Europe's Conference of INGOs (CINGO), in his capacity as expert consultant to the GT-CS. Overall, the CDDEM members expressed support for the study; one member commented on the need to ensure that the update of CM/Rec(2007)14 takes into account the possible risks associated with its implementation, in particular with regard to its unintended effects, and another member argued that specific examples of threats to civil society should be added to strengthen the evidence base for the study's conclusions. During the discussion, Mr McBride pointed to several issues that needed clarifying in the new text, such as the difference between "lobbying" and "advocacy" in the context of civil society activities, and he reiterated that the new recommendation should not weaken the requirements and achievements of the current recommendation.

Upon proposal by the Chair, it was agreed that further comments could be made in writing during the three weeks following the meeting. Any further comments would be considered, and if no further comments were received, the study would be considered approved. The Secretariat would then begin to prepare a new draft recommendation on the basis of the proposals in the Feasibility study. A first reading of the draft text would take place in the GT-CS in early 2025.

# 14. CDDEM contribution to the Steering Committee for Human Rights' (CDDH) Implementation Review Report on Recommendation CM/Rec(2018)11 of the Committee of Ministers to member States on the need to strengthen the protection and promotion of civil society space in Europe

The CDDEM reviewed and approved the contribution to the Steering Committee for Human Rights' (CDDH) implementation review of Recommendation CM/Rec(2018)11 on the need to strengthen the protection and promotion of civil society space in Europe. The CDDEM's contribution consists of a Compilation of member states' replies to the questionnaire on the implementation of the Recommendation, the Summary overview of the opinions of CINGO's Expert Council on NGO Law for the period 2019-2024, and the Summary of current work on strengthening civil society engagement in the Council of Europe.

Members heard from Mr Daniel Pap, Secretary of the drafting group of the Steering Committee for Human Rights on human rights and artificial intelligence (CDDH-IA), who provided information on the draft implementation review report on the 2018 Recommendation being prepared by the CDDH, and in particular on how the CDDEM contribution to the report would be used. The CDDH invited the CDDEM to be represented at the CDDH plenary meeting on 25-29 November 2024, and it was decided that the Secretariat would take on this role.

#### 15. Application for observer status

The CDDEM examined four applications for observer status and heard the presentation of the respective representatives of these organisations, namely (1) the Culture and Democracy Foundation, (2) the European Center for Human Rights, (3) the European Council of Spatial Planners, and (4) the CURE – Campaign to Uphold Rights in Europe.

Upon deliberation, the CDDEM approved the application of the Culture and Democracy Foundation for observer status. As the representative of Türkiye indicated that the other applications had not been received in time for consideration, the CDDEM decided to initiate a three-week tacit procedure, whereby observer status would be deemed granted to the organisations concerned if no objections were raised by 20 November 2024.

# 16. Exchange of views with Michael O' Flaherty, Commissioner for Human Rights of the Council of Europe

The CDDEM held an exchange of views with Mr Michael O'Flaherty, Commissioner for Human Rights of the Council of Europe, who presented his mandate and work, underlined the interrelationship between human rights and democracy, and stressed the indivisibility of human rights. He noted the particular importance of social rights as a roadmap to achieving social justice and thereby supporting trust in democratic governance. The Commissioner referred to the important human rights work of civil society organisations and local authorities, emphasising the need to involve the rightsholders at all levels.

The Commissioner further noted four issues of concern, relating to the cross-over between democracy and human rights: (1) gaining control over processes involving artificial intelligence; (2) the growing pressure on civil society in Europe, including through the criminalisation of their work and activities; (3) the erosion of the rule of law at the European borders, and (4) the disappearance of education about human rights and democracy from many curriculums over the past years.

In response to a question on how to engage with actors who undermine democracy and the rule of law, Mr O'Flaherty responded that it was important to stress the principles behind human rights rather than referring to them merely as imposed obligations. The ensuing discussion covered other topics, including the need for genuine youth participation, priority areas to address, definitions of civil society, and ways of operationalising the Reykjavik Declaration. In conclusion, the Commissioner offered the Committee the full cooperation of his Office.

# 17. Update on the European Union developments and initiatives related to safeguarding democracy

The CDDEM took note of the update on the EU initiatives related to safeguarding democracy provided by Ms Marie-Hélène Boulanger, Deputy Director and Head of Unit in charge of Democracy, Citizenship and Free Movement at the European Commission (DG JUST). Ms Boulanger informed the Committee about the implementation of the Defence of Democracy Package and the planned "European Democracy Shield" that is to strengthen the EU's capacities for countering disinformation and building resilience against information manipulation. The new Commission will have as one of its priorities to provide a "new push for democracy" by focussing on the protection of election integrity; increasing transparency, including transparency and accountability of interest representation activities; the engagement of citizens and civil society, and implementing the Directive on SLAPPs. Reflecting on the future of the Commission's democracy-agenda, Ms Boulanger highlighted the importance of effectively countering disinformation and foreign interference, and of building societal resilience alongside resilience of democratic institutions and processes, for which participatory democracy is key.

# 18. Update on the work of the Parliamentary Assembly Committee on Political Affairs and Democracy

The Committee took note of the information provided by Mr Cesare Colombo, Co-Secretary of the Parliamentary Assembly's Committee on Political Affairs and Democracy (AS/Pol), on the current work and initiatives of the PACE committee. Mr Colombo briefly presented some of the reports currently under preparation, namely on "Foreign interference: a threat to democratic security in Europe"; "Violence and hate speech against politicians: a threat to democracy"; "Elections in times of crisis"; "Protecting democracy from disruptions caused by artificial intelligence"; and "Political parties and democracy". Mr Colombo also briefly provided information on the PACE's monitoring committee and mechanism, and highlighted that the potential value of the Parameters that are being developed by the CDDEM to that mechanism. Finally, Mr Colombo expressed the PACE committee's readiness to continuously and actively contribute to the CDDEM's work and co-operate on the deliverables under preparation, as appropriate.

#### 19. Recent developments in the areas of activity of the CDDEM

Committee members and participants presented ongoing and upcoming developments and initiatives in member states and/or organisations in the areas of democracy, good democratic governance, elections, safe and enabling civic space and other areas of activity of the CDDEM.

Mr Pavel Mička (Czechia) informed the CDDEM about a consortium of six countries, including Czechia, that have prepared a Technical Support Instrument (TSI) project focussing on participatory and deliberative democracy with the support of the Organisation for Economic Co-operation and Development (OECD), expressing the hope that the Council of Europe would contribute to the project. He also mentioned his participation in a training on citizens assemblies organised by the Council of Europe in co-operation with the Bertelsmann Stiftung.

Mr Niklas Wilhelmsson (Finland) informed the Committee that Finland is preparing a democracy policy programme, with a government resolution expected to be published in January 2025, also based on Council of Europe documents. The resolution is to focus on securing elections and electoral participation, enhancing civic and human rights education, and new forms of political participation. A government resolution on the development of civic space had also been prepared (CSO strategy), and Mr Wilhelmsson was going to circulate among the members. Furthermore, Finland was one of four countries participating in International IDEA's pilot project on the protection of elections; the end report for which is expected to be released in spring 2025.

Ms Silvia Negro Alousque (Spain) informed the other members of the development of a three-year action plan for democracy for ensuring truthful information and confidence in democracy. Areas of focus are the quality of governance, media plurality, and transparency in the electoral and legislative systems.

Mr Grégory Sterck (Belgium) informed members about the recent elections in the Brussels capital region, which were the first Belgian elections that took place in an entirely electronic format. Mr Sterck further informed the Committee that following a recently adopted amendment in the Region, simultaneous holding of a legislative and a local executive mandate would no longer be possible, although the implementation of this amendment is still under development and negotiation.

Ms Lilya Afrikyan (Armenia) informed members about recent regulations for improving public monitoring and observation of public procurement, including post-procurement processes, directed towards CSOs, with the aim of raising the transparency and integrity of public officials. She also provided information on a campaign organised by local CSOs civic to collect citizens' signatures on bringing Armenia closer in line with the European agenda.

Ms Oksana Pavliuk (Ukraine) informed the Committee about a range of recent developments in Ukraine's continuing de-centralisation efforts, including the adoption of a new law on public consultation, a comprehensive regulation to balance public and private interests; a law aimed at creating conditions for civil participation in public life on local level, and the development of a new action plan implementing a national strategy for developing civil society participation until 2026.

Mr Christian Aldenhoff (Germany) informed the Committee that the Federal government had adopted a strategy to promote a strong and pluralist society employing a holistic approach, with the aim of countering extremism.

Ms Hanneke Palm (Netherlands) informed the members that Dutch law on Strengthening participation at decentralized level had recently entered into force which is to promote citizen participation in policyand decision-making. This law aims to strengthen the involvement of citizens in policy implementation and evaluation in municipalities and provinces.

Mr Ahmet Evren Bal (Türkiye) asked for members to share programmes, strategies, and developments in writing, and for the Secretariat to circulate them within the Committee.

Finally, Mr Roberto Lattanzi (Italy) informed the CDDEM that an open government plan is being implemented, which aims to increase civic participation, promote inclusion and access to documents. This is an ongoing activity, in line with European Commission recommendations, and currently in its 6<sup>th</sup> year of operation.

#### 20. Participation in events of relevance to the CDDEM

Mr Paulius Skardžius (Lithuania) informed members about the key findings of the conference on "Multilevel Governance for Ensuring Democracy and Strengthening Resilience at all Levels of Governance", which took place on 25 September in Vilnius. The conference was organised by the Lithuanian Ministry of Interior with the support of the Congress of Local and Regional Authorities in the framework of the Lithuanian presidency of the Committee of Ministers.

Ms Katrin Kivi (Estonia) informed members about an online event organised by International IDEA, the (OECD) and other organisations on the future of the Summit for Democracy, and proposed that the Council of Europe strengthens the synergies with these organisations and other relevant forums dealing with democracy challenges. In this connection, the members mentioned also the OECD's Reinforcing Democracy Initiative and the EU's existing action plans on democracy.

Ms Lilya Afrikyan (Armenia) highlighted the open government initiatives and informed members that a summit would be held in 2025, in which the Committee could be involved. The Vice-Chair suggested that the Bureau look into the possibilities, including to potentially invite some of the key players to the CDDEM.

The Secretariat informed the CDDEM members on existing and ongoing Council of Europe participatory and deliberative democracy initiatives, and invited them to consider hosting events on the topics concerned in their countries.

Mr Robert Tabone (Malta) informed the members that, in the framework of its upcoming Committee of Ministers presidency, Malta would host a conference on multi-level governance in 2025, on which more information would be shared soon.

#### 21. CDDEM Calendar of Meetings for 2025

The Committee approved the proposed calendar of meetings for 2025 and agreed to hold its 3rd and 4th plenary meetings in a hybrid format, in Strasbourg and online, on 12-13 June and 27-28 November 2025 respectively.

#### 22. Any other business

The CDDEM discussed the importance of engaging with the Committee on Artificial Intelligence (CAI) that is developing operational tools for the implementation of the Framework Convention on Artificial Intelligence and Human Rights, Democracy and the Rule of Law (CETS No. 225), which includes a provision on the impact of AI on democracy. Mr Roberto Lattanzi (Italy), who is also a member of the CAI, offered to inform the CDDEM about the CAI's legally non-binding methodology for the Risk and Impact Assessment of AI Systems from the point of view of Human Rights, Democracy and Rule of Law (HUDERIA) that would be finalised by the end of the year and is to support the implementation of the Framework Convention.
