# Implementation of the Council of Europe Strategy for the Rights of the Child (2016-2021)

**Action Plan** 

Last update: 17 May 2021

Document prepared by the Children's Rights Division Directorate of Anti-Discrimination The <u>Council of Europe Strategy for the Rights of the Child</u> (2016-2021) was adopted by the Committee of Ministers on 3 March 2016. Overseeing the implementation of the Strategy was first assigned to the <u>Ad-hoc Committee for the Rights of the Child</u> (<u>CAHENF</u>) then, as of 2020, to the <u>Steering Committee for the Rights of the Child</u> (<u>CDENF</u>).

To facilitate this task for the respective Committee, the present Action plan lists planned, on-going and completed activities (outputs) aiming at the realisation of the objectives (expected outcomes) set out in the Strategy.

The document is updated regularly by the Secretariat of the Children's Rights Division on the basis of information received from different sectors of the Council of Europe via the Inter-Secretariat Task Force on the Rights of the Child, the CDENF, and other relevant stakeholders. It therefore integrates activities carried out by Council of Europe monitoring, intergovernmental and other bodies, and administrative entities. As the latter are guided by their own respective mandates and work plans, their activities are listed for information only.
