Background and CDENF Bureau action required

- 1. Under its current <u>Terms of Reference (2022-2025)</u> the CDENF is instructed by the Committee of Ministers to review the implementation of the following Committee of Ministers' recommendations:
 - Recommendation CM/Rec(2019)11 on effective guardianship for unaccompanied and separated children in the context of migration, by 31/12/2023;
 - <u>Recommendation CM/Rec(2009)10</u> on Council of Europe policy guidelines on integrated national strategies for the protection of children from violence, including the development of model prevention approaches, by 31/12/2024
 - Guidelines on child-friendly justice (and development of further guidance), by 31/12/2025
 - <u>Recommendation Rec(2005)5</u> on the Rights of children living in residential institutions, by 31/12/2025.
- 2. Other Committee of Ministers' Recommendations also foresee the examination of their implementation at periodic intervals. That is the case of Recommendation CM/Rec(2018)7 of the Committee of Ministers to member States on Guidelines to respect, protect and fulfil the rights of the child in the digital environment, which foresees an implementation review every five years.
- 3. With the aim of streamlining the process of implementation review and follow-up of national action taken in fulfilment of Council of Europe standards, the following methodology is proposed. The present document includes a draft outline, illustrating the steps to be followed for conducting implementation reviews of Committee of Ministers' Recommendations and should serve as a guide for the CDENF to carry out implementation reviews, while remaining flexible and adaptable to the specific subject matter and procedural features of each Recommendation. As appropriate, the CDENF may have recourse to external consultants to support this process (subject to the provisions of the resolution Res(2004)25[3] on service contracts of consultants and within the limits of budgetary appropriations).

 - g. Transnational co-operation
 - h. Capacity-building measures and procedures developed at national level to support practitioners
 - i. Impact of the Recommendation based on evidence
 - j. Others
