### Meeting details

The Steering Committee on Media and Information Society (CDMSI) held its 26<sup>th</sup> meeting in Strasbourg on 4-6 December 2024 with Maja ZARIĆ (Serbia) as Chair.

The agenda of the meeting is in Appendix 1. The full report of the meeting including the list of participants will be made available on the CDMSI website.

Total number of participants: 103. Gender distribution: 53 men (55%) and 50 women (45%).

- welcomed the progress made and provided further input on the **draft deliverables of its two committees of experts:**

- the [Committee of Experts on online safety and empowerment of content creators and users](#) (MSI-eSEC), mandated to deliver a *draft Recommendation on online safety and empowerment of content creators and users* by the end of 2025, which held its second meeting on 24-25 September 2024 in Strasbourg. The outcome, progress and next steps were presented by Nicole Stellou, Chair of MSI-eSEC, and Martin Husovec, Drafting Co-rapporteur.

- the [Committee of Experts on the implications of generative artificial intelligence for freedom of expression](#) (MSI-AI), mandated to deliver a *draft Guidance Note on the implications of generative artificial intelligence for freedom of expression* by the end of 2025, which held its second meeting on 17-18 October 2024 in Strasbourg. The outcome, progress and next steps were presented by Andrin Eichin, Chair of MSI-AI, and Iva Nenadic, Drafting Co-rapporteur.
- Took note of and exchanged views on the updates provided by the Secretariat on the **ongoing work on other future CDMSI deliverables**, including on:
  - **“Indicators for media and information literacy (MIL) strategies at national level”**, benefitting of a presentation was delivered by Nicoleta Fotiade, Media Literacy Educator and Trainer, Associated to Mediawise Society and International Association for Media Education, and on which the Secretariat will circulate a questionnaire to gather feedback and input from CDMSI members;
  - **“Ten steps to counter disinformation - Strategy and practical tools based on existing Council of Europe standards and other instruments”**, on which the Secretariat will circulate a questionnaire to gather feedback and input from CDMSI members;
  - **“Feasibility Study on Immersive Reality Applications and their Implications for Freedom of Expression”**, which preliminary findings were presented by Brittan Heller, International Law, Technology, and Human Rights expert, and for which the Secretariat invited CDMSI members to submit additional input and comments.
- **Exchanged with** Terje Birkrem Hovland (Norway), Chair of the [Steering Committee for Culture, Heritage and Landscape](#) (CDCPP), on developments regarding the Council of Europe's forthcoming legal mechanism to support the production of European drama series, including the extent of CDMSI's involvement and related opportunities to provide feedback.
- **Agreed to provide** additional input and comments on the preparatory work conducted by the Secretariat of the Council of Europe International Cooperation Group on Drugs and Addictions (Pompidou Group) for a future draft Recommendation, which will be presented to the CDMSI ahead of its next Plenary meeting, prior to its submission to the Committee of Ministers for adoption. In this framework, Elena Hedoux, Deputy to the Executive Secretary of the Pompidou Group, presented the Policy paper on strategies and regulatory options aimed at reducing risks and harms related to online gaming and online gambling.
