# LIST OF DECISIONS 80th PLENARY SESSION

Strasbourg, 7-9 December 2021

Teleconference (hybrid)

The CDPC, meeting via videoconference (hybrid), under the Chairmanship of Mr Jesper Hjortenberg (Denmark), took the following decisions:

1. Opening of the meeting by Mr Jan Kleijssen, Director, Information Society and Action against Crime Directorate

to take note of the introductory remarks by Mr Kleijssen and in particular of:

- the terms of reference of the CDPC and the other intergovernmental committees of the Council of Europe were adopted by the Committee of Ministers on 24 November 2021;
- the terms of reference of the new Committee of Experts on Hate Crime (PC/ADI-CH), subordinate to the CDPC and to the Steering Committee on Anti-Discrimination, Diversity and Inclusion (CDADI) with the task to prepare a Draft comprehensive Recommendation on combating hate crime were adopted as well;
- a new Committee on Artificial Intelligence (CAI) which succeeds the CAHAI has been set up
  and is tasked to develop an "appropriate legal instrument on the development, design, and
  application of artificial intelligence systems based on the Council of Europe's standards and
  conducive to innovation";

on 5 October this year, the Hungarian Presidency of the Council of Europe hosted a Ministers
of Justice Conference in Budapest on the digitalisation of justice and the use of AI in judicial
proceedings which was preceded on 4 October by a Roundtable on new means of
communication for international cooperation in criminal matters;

- the main priorities of the Italian Presidency are: a) commitment to the founding values and principles of the Council of Europe; b) initiatives focused on the identity of the Organisation; c) the construction of a people orientated future, starting with the challenges posed by technology to human rights, such as the application of AI and the promotion of a citizenfriendly judicial system.
- the important role the CDPC will play in the elaboration of legal instruments on Council of Europe priorities on the protection of the environment through criminal law and on AI and criminal law related to the automated driving of vehicles;
- the work by the PC-OC, notably the issue of co-operation with the European Public Prosecutor's Office (EPPO) and the discussions regarding a binding legal instrument in this respect;
- the CDPC's first steps towards drafting a new recommendation on the rights of victims.

#### 2. Adoption of the draft agenda

- to adopt the draft agenda of the meeting (the list of participants and the agenda appear in Appendices I and II respectively).

#### 3. Information by the Chair, the Delegations of the CDPC and the Secretariat

 to take note of the information provided by its Chair, Mr Jesper Hjortenberg, and the Secretariat on activities undertaken since the last CDPC Plenary meeting as well as recent developments of relevance to the work of the CDPC, including the outcome of the last CDCP Bureau meeting.

#### 4. Completed, ongoing and future activities of the CDPC

#### a. Terms of reference of the CDPC (2022-2025)

- to take note that the terms of reference of the CDPC have been adopted by the Committee of Ministers in November with few minor adjustments concerning the deliverables.

#### b. Action Plan on Smuggling of migrants

- to endorse the decisions of the CDPC Bureau on this item: to launch the implementation of action n°1 at the beginning of 2022, despite the sanitary situation, and to liaise with the European Union, as a major related project has started at its level;
- to encourage members of the CDPC to designate national experts (including prosecutors or lawenforcement officials) specialised on issues related to smuggling of migrants, who will be involved in the implementation of action n°1, which will start during the first semester of 2022. The Secretariat will send an official invitation to all members of the CDPC in this regard.

#### 5. Protection of witnesses and collaborators of justice

- to take note of the information provided by Mr Jesper Hjortenberg, Chair of the Drafting Working Group on the Protection of Witnesses and Collaborators of Justice (CDPC-PWCJ) about the deliberations of the 3rd and final meeting of the Drafting Working Group which took place on 18-19 October 2021, in Paris;
- to examine, finalise, approve the draft Recommendation on the Protection of Witnesses and Collaborators of Justice and its draft Explanatory Memorandum;

 to instruct the Secretariat to submit the draft Recommendation on the Protection of Witnesses and Collaborators of Justice to the Committee of Ministers for final adoption and the draft Explanatory Memorandum for information.

#### 6. Hate Crime

- to have an exchange of views with Mr Jamie Brown, the co-Secretary of the newly established Committee of Experts on Hate Crime (PC/ADI-CH), which is to be a subordinate body of the CDPC and the Steering Committee on Anti-Discrimination, Diversity and Inclusion (CDADI);
- to take note that the first meeting of the PC/ADI-CH is tentatively scheduled to take place in February 2022 on the Council of Europe premises in Strasbourg and that the work (draft a Council of Europe Recommendation on hate crime) will be finalised by the end of 2023.

#### 7. Council for Penological Co-operation (PC-CP) – Exchange of views with the Chair, Ms Annie Devos

- to have an exchange of views with Ms Annie Devos (Belgium), the PC-CP Chair, regarding the past and planned work of the PC-CP, notably:
  - after the CDPC plenary meeting in June 2021, one PC-CP WG meeting was held on 18-19 September 2021 in Madeira in preparation of the 26th Conference of Directors of Prison and Probation Services (20-21 September 2021) at which the working documents on mental health and on artificial intelligence were discussed in greater details including the presentations to be made in relation to this at the Conference by the scientific experts. [See Docs. PC-CP(2021)8Rev2 and PC-CP(2021)9rev];
  - that the PC-CP held its plenary meeting on 22-23 November 2021 (in a hybrid format) and that it was preceded by a half-day Conference commemorating the 40th anniversary of the PC-CP. On its agenda was the continuation of the work on the management by prison and probation services of offenders with mental health disabilities and disorders as well as on the ethical, structural and organisational aspects of the use of AI by the prison and probation services. The Conference and the meeting were attended by 97 participants from 36 member States [See Doc. PC-CP (2021)15];
  - that the PC-CP has agreed that the work on mental health will be finalised at the end of 2022 (A White Paper) and the work on AI (CM Recommendation) will be finalised at the end of 2023 thus allowing more time for reflexion on this topic so that it will also be better coordinated with the work plan of CAHAI and its successor CAI;
  - an agreement was reached by the members of the PC-CP WG that the Chair and Vice-Chair will switch their places as of January 2022 in order to ensure the continuity of the current work carried out by the PC-CP on mental health and on artificial intelligence. As a result of this decision the terms of office of three members of the PC CP Working Group will expire in December 2021 and elections to fill in the three vacancies will be carried out during the present plenary session of the CDPC. # a. 26th Council of Europe Conference of Directors of Prison and Probation Services (CDPPS) (held on 20-21 September 2021 in Portugal)

- to take note that the Conference (held in a hybrid format) was attended by more than 120 participants of whom more than 80 attended in person and that it was opened by the Portuguese Minister of Justice. It was considered of great importance and value by all participants. (See www.coe.int/cdpps2021 and Doc. PC-CP(2021)14].

#### b. Items for information

- to take note that the 3rd and last EU/CoE co-funded project ("SPACE and National Preventive Mechanisms": JUST-JCOO-COEU-AG-2018) ended on 30 September 2021 and that the proceedings of the two Conferences held online were collected, processed and published by the SPACE team at the University of Lausanne (See.www.coe.int/prison).

#### 8. Artificial Intelligence and criminal law

- to have an exchange of views with Mr Jesper Hjortenberg, Chair of the Drafting Committee to elaborate an instrument on AI and Criminal Law (CDPC-AICL), who provided information regarding the 1st meeting of this Committee, held on 15-16 November 2021 in hybrid format;
- to take note that, ahead of the next meeting of CDPC-AICL which is scheduled to take place on 31 March and 1 April 2022 on the Council of Europe premises in Paris, the AICL decided that the Secretariat will re-distribute the compilation of answers to the 2019 questionnaire so that delegations can provide updated information, notably concerning evolutions with regards to their legislative and regulatory frameworks in the relevant field, and that a framework document containing a substantial outline of the elements that will be included in the future instrument will be prepared.

## 9. Committee of Experts on the operation of European conventions on co-operation in criminal matters (PC-OC) – Exchange of views with the President ad interim, Mr Erik Verbert

- to have an exchange of views with Mr Erik Verbert, Chair ad interim of the PC-OC, to take note of the lists of decisions of the 80th plenary meeting of the PC-OC (22-23 November 2021) and of the 31st meeting of the PC-OC Mod (7-9 September 2021) and to have an in-depth discussion on the issue of co-operation with the European Public Prosecutor's Office (EPPO) with the intervention of many delegations;
- to take note of the conclusions of the PC-OC regarding the need for a binding instrument in the form of an agreement between the EU and the Parties to the European Convention on Mutual Assistance in Criminal Matters on the application of this 1959 Convention and the Additional Protocols thereto for the co-operation with the EPPO;
- to take note with great attention of the information communicated by Mr Klemen Princes (Slovenia), on behalf of the EU, presenting the outcome of the recent COPEN WP where the EU Member States concluded that 1) they attach great importance to finding suitable solutions for the cooperation between the EPPO and the non-EU Parties under the 1959 European Convention and its Protocols; 2) welcome all efforts made by the CoE in this regard; 3) EU member States are and remain open to consider any suitable long-term solution, including a self-standing binding instrument; 4) the importance to further explore if and to what extent the unilateral declarations can be considered as an appropriate legal basis and receive any relevant information from the non-EU partners; 5) the EU Member States consider that they will not yet be in a position to recommend to the Committee of Ministers of the Council of Europe to agree on a mandate for a self-standing binding instrument, as proposed by PC-OC; 6) following the exchange with non-EU partners, it will be possible to have a clearer picture of the situation, and this will allow to consider any appropriate way forward, to be explored in particular at technical and expert level:
- to note that the subsequent discussion did not allow to clarify sufficiently the position of member States that are non-EU Parties to the 1959 Convention and that further information would be needed;
- to instruct the PC-OC to send out a short questionnaire to non-EU Parties to the 1959 Convention
  to obtain further clarity about their position regarding co-operation with the EPPO, existing
  obstacles and possible solutions in time before the next meeting of the PC-OC Mod and report the
  outcome to the CDPC in view of a decision;
- to take note of the discussions of the PC-OC on possible provisions to be developed in a future additional Protocol to the European Convention on Mutual Assistance in Criminal Matters;
- to take note of the organisation of a special session on international co-operation on asset recovery to be organised in co-operation with the COP 198 during the next plenary meeting of the PC-OC in May 2021;
- to take note of the election of Ms Joana Gomes Ferreira (Portugal) as Chair and of Mr Adil Abilov (Azerbaijan) as Vice-Chair of the PC-OC.

#### 10. Environment and Criminal Law

- to have an exchange of views with Mr Thomas Grégoire, Chair of the Working Group on the Environment and Criminal Law (CDPC-EC), who provided information about the outcomes of the deliberations of the 3rd meeting of the Working Group, held on 7 October 2021, online;

- to take note that the 4th meeting of this Working Group is scheduled to take place in February 2022, where a revised version of the Feasibility Study on a possible new CoE Convention on the Protection of the Environment through Criminal Law will be examined. It will reflect the viewpoints expressed at the previous meeting by the experts of the Working Group regarding the need to draft a possible instrument in order to obtain the necessary ratifications for its entry into force and therefore to avoid the mistakes made when drafting the 1998 Convention that never entered into force and was ratified only by one State; the harmonisation between administrative and penal law in this area and the need for coordination with the EU work are two key elements also highlighted by the CDPC.
- to consider this topic as its high-priority for 2022 and a subject of great importance both for the Council of Europe and for its member States.

#### 11. Victims' rights

- to take note of the information provided by the Secretariat on this item, namely that following the
  deadline of 15 October 2021, to date, 17 States have appointed experts for the Working Group to
  draft a Recommendation on the rights of victims taking into account the rights and position of
  offenders and other persons involved in the criminal law process;
- to take note that the delegations can still appoint experts to the Working Group before its first meeting:
- to take note that given the availability of the two Scientific Experts, Profs Suzan van der Aa and Antony Pemberton, the first meeting of this Working Group is scheduled to take place in February 2022.

## 12. Cybercrime Convention Committee (T-CY) – Exchange of views with Mr Alexander Seger, Secretary to the T-CY

- to take note of the information provided by the Secretary of the T-CY, Mr Alexander Seger, regarding the latest developments in the T-CY work since the last CDPC plenary meeting particularly with regard to developments relating to the 2nd additional protocol to the Budapest Convention which was adopted by the Committee of Ministers on 17 November 2021 and should be opened for signatures in May 2022;
- to congratulate the achievement of this important work realised by the T-CY and welcome the new Protocol as an important legal instrument for the effective investigations in criminal cases and in international co-operation in criminal matters.

## 13. Revitalising criminal justice work of the Council of Europe, with particular regard to Articles 5 and 6 of the European Convention on Human Rights. Proposal by the United Kingdom

- to have an exchange of views with the representatives of the delegation of the United Kingdom on this item:
- to consider and approve the draft proposal of the Declaration by the Committee of Ministers on the need to revitalise the criminal justice work of the Council of Europe with a focus on procedural rights under Articles 5 and 6, with some amendments to the text submitted;

 to instruct the Secretariat to submit this revised text to the Committee of Ministers for final adoption, as soon as the delegation of the United Kingdom will also agree on the amendments agreed by all other delegations of the CDPC.

#### 14. Elections

The CDPC elected:

- Katariina Jahkola (Finland) as its Chair;
- Thomas Grégoire (France) as its Vice-Chair;
- Stefano Filletti (Malta) as member of the Bureau;
- Jesper Hjortenberg (Denmark) as member of the Bureau;
- Anita Marfurt (Switzerland) as member of the Bureau;
- Fritz Zeder (Austria) as member of the Bureau.
- to thank Mr Jesper Hjortenberg for his excellent stewardship of the Committee over the last two years, particularly with the challenges presented by the ongoing Covid-19 pandemic.

The CDPC elected the following new members of the PC-CP WG:

- Jorge Monteiro (Portugal);
- Paulina Tallroth (Finland);
- Dominik Lehner (Switzerland).

#### 15. Information points

to note that the forthcoming Italian Presidency will hold a Ministers of Justice Conference "Crime and Criminal Justice – What is the Role of Restorative Justice in Europe" (13-14 December 2021, Venice, Italy). In preparation for this Conference a meeting of Senior Officials from the Ministries of Justice was held in Como, Italy on 12-13 October 2021. Three main topics were discussed: the use of Restorative Justice in the case of juvenile perpetrators or victims; the use of Restorative Justice as a complement to the criminal justice system to help desistence from crime, victims' recovery and offenders redress and reintegration and training in Restorative Justice of justice professionals. The overall aim of the Italian Presidency is to promote the widespread use of Restorative Justice in Europe by adopting a Declaration of the European Ministers of Justice at the Conference in Venice. The draft Declaration will be sent out to the member states by the Italian authorities in due course before the start of the Conference.

#### a. CAHAI

- to take note of the information provided by the Secretariat regarding the work done by CAHAI, namely a Feasibility Study on the possible legal framework and a list of recommended elements addressed to the CM to form part of the possible transversal legal framework (finalised on 2 December 2021);
- to take note of the human rights/democracy/rule of law impact assessment package that should also be part of the framework

#### b. Medicrime

- to take note that the Medicrime Convention celebrates its 10th anniversary this year and that a
  plenary meeting of the Committee of the Parties was held last week and next week there will be a
  meeting of the 24/7 network Working Group open to all countries and not only to the States parties;
- to note further that the Convention has 18 State Parties of which only 6 are EU members and 4 others are Council of Europe members and make an appeal to the remaining member States to ratify the Convention.
- **c.** Terrorism

- to take note that in October 2021 the Committee of Ministers adopted a Recommendation on the protection of children from radicalisation prepared by the CDCT and that the CDCT will prepare a new Counterterrorism Strategy to be implemented as of 1 January 2023 to tackle emerging terrorist threats and cover other topical issues;

to take note that at the last CDCT plenary draft Recommendation on Risk Assessment of persons indicted or convicted for terrorist offences was approved and that it will be submitted to the Committee of Ministers at the beginning of next year and that the draft Recommendation on "The use of information collected in conflict zones as evidence in criminal proceedings related to terrorist offences" finalised by the CDCT in May 2021 is still pending before the Committee of Ministers for final adoption and will be examined by the GR-J (Rapporteur Group on Legal Co-operation of the Committee of Ministers) in February 2022.

#### d. Council of Europe Convention on Offences relating to Cultural Property

- to take note of the entry into force on 1 April 2022 of the Council of Europe Convention on Offences relating to Cultural Property following the 5th ratification by Hungary and that 8 more countries have signed it so far;
- to make an appeal to the national authorities of the remaining member States to sign and ratify this Convention drafted by the CDPC.

#### 16. Any other business

The CDPC thanked Mr Hans-Holger Herrnfeld since this was his last meeting as a member of the committee and expressed its gratitude for Mr Herrnfeld's enormous contribution to the work of the Council of Europe in general and of the CDPC in particular over a period of many years.

The CDPC expressed its gratitude to Ms Anita van de Kar, Secretary to the PC-OC, for her excellent work in the international co-operation in criminal matters area and for the CDPC. Ms van de Kar will soon retire after a successful career in the Council of Europe.

#### a. Election of the Gender Equality Rapporteur

- to welcome Ms Kateryna Shevchenko (Ukraine) and appoint her as the new CDPC Gender Equality Rapporteur.

# b. Draft Opinion on Parliamentary Assembly Recommendation 2213 (2021) "Addressing issues of criminal and civil liability in the context of climate change"

- to consider and approve the draft opinion by the CDPC for the Committee of Ministers in reply to Recommendation 2213 (2021) of the Parliamentary Assembly of the Council of Europe on "Addressing Issues of Criminal and Civil Liability in the Context of Climate change".
- to instruct the Secretariat to submit it to the Committee of Ministers.

#### 17. Dates of the next meetings

 to decide that the dates of its next Plenary meeting will be during the week starting on 13 June 2022.
