Responsibilities:

As a Prison Governor and as a Program Director, I am in charge of several strategic projects for the French Department of Justice. Currently, I lead and coordinate the strategy and the implementation of two projects with a strong IT component. The first one is "mobility services in correction" and the other one is to sustain penitentiary labour reform. In fact, I am responsible for a budget of 10 million euros to achieve the expected outcomes of these two projects both on strategic and operational aspects.

Mobility: I am responsible of elaborating, deploying and launching a new digital software for prison officers. The aim is to offer them more mobility capacities to achieve their daily goals and tasks. First, the French Prison Department want to build and experiment a new software on smartphone for these agents. Then, our approach is to assess and analyse the impacts of this new digital software on professional practices and specifically on the relation between prison officer and inmates. We expect two main outcomes for this project: improving penitentiary management of prisoners and increasing the effectiveness and the quality of work for professionals of Justice.

Penitentiary labour reform: I am in charge of defining a new strategy and a new organization for the prison labour programs in all French prisons. I also analyse the impacts of the law reform on inmates' rights and enforce their social rights. The aim is to implement a new Human Resources Information System including solutions in training, payroll, HR, compliance and recruitment for the prison labour programs. We also prepare, build and use the necessary change management tools to mobilize the prison officers and more globally the employees of the French Prison Department in the context of this law reform.

I developed some digital and office automation skills. I have yet a special **expertise on information system**, **data science and office software**.

Conde-Sur-Sarthe Penitentiary Center is a maximum-security prison. An enhanced surveillance is exercising due to prison course and criminal profile of inmates. The main aim for this kind of prisoner's management is to find the balance between security and insertion care to allow a positive outcome after this incarceration. For that, a new method to work is necessary between prison officer and insertion services. They have to work hand to maximise chance to succeed. This is a work with long-term prisoners and all professional have to be a prosocial model to ensure the enhancement of soft skills' inmates.

Responsibilities:

- Leading and managing prison officers and chief prison officer
- Charging with the complete security of the detention
- Animating meetings with all prison's services to optimize inmates' support, including family links
- Representing the Prison Governor in meetings with others state services
- Crisis management
- Finding the balance between security and reintegration

This partnership allows exchanging professional practices and point of view to optimize global care for prisoners including medical care service and National Education.

- . Frequent participations at meetings with European experts about technologies increasing efficiency of correction and probation public services. Currently, we are working on a matrix to identify experimentations and prospective works toward prison services. With this document, it will be easier to share feedback and solicit someone for our own projects. We also study some disrupting subjects like artificial intelligence and virtual reality. 2020's works found their foundations on covid-19 crisis, especially how digital tools could support continuance of justice services during this singular period.
- . "technologies in correction" organizes international workshop:
- $-under \, construction: the 4th \, technology \, in \, corrections \, conference \, "disrupting \, corrections" \, scheduled \, for \, 28-30 \, April \, 2021$
- 29-30 September 2020: online workshop about "Information and Communication Technologies in prisons". Some European prison services promoted 14 themes. The presentations were coming from Netherlands, Sweden, Croatia, Italia, United Kingdom, Ireland, Spain, Finland, Turkey, Austria, Luxembourg and France. Personally, I presented a subject about mobility services called "outdoor missions, mobility and future network".

PENITENTIARY STUDIES TRIP (November 2019) NORWAY

Organized by French Penitentiary Academy, I had the opportunity to study during one week the Norway Penitentiary System. I visited **Bastoy Opening Prison**, the University College of Norwegian Correctional Service (KRUS) and a halfway house. In this last visit, Correctional Service presented "Drug Court Program" and "Drunk Drivers Program". This experience was strong enough to discover "import model" and "normality principle", two pillars of the Norway Penitentiary philosophy.

PROJECTS

- In 2018, assigned to the prison governor to create a special radicalization unit.
- 2017 / 2019 : **core correctional soft skills training** : in collaboration with a psychologist, I elaborated a training for penitentiary professionals. Working on their emotional intelligence and on some others soft skills, this training aims to: reinforce communication and relation link between inmates and prison officers; limit psychosocial risks for prison officers. This training was deployed through the big west regional directorate. In particular, it was included in the instruction for prison officer assigned to « radicalization unit ».
- "RESPIRE" collective care elaboration and promotion: a work group was installed in the big west regional directorate for elaborating an inmates collective care in order to increase their capacities to manage anger. With some probation and insertion professionals and some psychologists, I worked on the educational content and the way to implement it in correction. In addition, I was in charge to promote this project to the french prison department. This collective care was the first ever animated by a couple of probation officer and prison officer. One goal of this project was to permit the reunion of correction and probation professionals to elaborate a 360° evaluation.
