## LIST OF DECISIONS

### 79th PLENARY SESSION

Strasbourg, 28-30 June 2021

Teleconference

---

The CDPC, meeting remotely via videoconference, under the Chairmanship of Mr Jesper Hjortenbergh (Denmark), took the following decisions:

**1. Opening of the meeting by Mr Jan Kleijssen, Director, Information Society and Action against Crime Directorate**

To take note of the introductory remarks by Mr Kleijssen and in particular of:

- the continuing need to meet online, but that despite this the CDPC carries out its work as planned;
- the implementation of the Strategic Framework of the Council of Europe and its effects (namely the four-year programming cycle coupled with two biennial budgets);
- the information that on 5 October this year, the Hungarian Presidency of the Council of Europe is planning to host a Ministers of Justice Conference in Budapest on the digitalization of justice and the use of AI in judicial proceedings. It will be preceded on 4 October by a Roundtable on new means of communication for international cooperation in criminal matters;
- the important role the CDPC will play in the elaboration of an instrument on AI and criminal law related to the automated driving of vehicles;

- the importance of the second priority area: the protection of the environment where a possible new legal instrument is expected with great anticipation. In relation to this to take note of the highly praised role of the Committee in developing very important legal instruments over the course of the years despite some difficulties due to the sensitive areas being regulated;
- the finalisation by the PC-CP of the draft Recommendation regarding the assessment, management and reintegration of persons accused or convicted of a sexual offence and its draft explanatory report;
- the organisation of the 26th Conference of Directors of Prison and Probation Services in September in Portugal;
- the work by the PC-OC, notably the issue of co-operation with the European Public Prosecutor's Office (EPPO) and the first steps taken towards the drafting of a new protocol to the 1959 Convention on Mutual Assistance in Criminal Matters to provide a solid legal basis for this cooperation, in consultation with the European Commission;
- the successful organisation on 5 May this year by the German Ministry of Justice during its Committee of Ministers Presidency of the Conference on Strengthening international co-operation in criminal matters which addressed important issues like the cooperation with the EPPO on MLA and several developments affecting extradition;
- the CDPC's first steps towards drafting a new recommendation on the rights of victims.

## **2. Adoption of the draft agenda**

- to adopt the draft agenda of the meeting (the list of participants and the agenda appear in Appendices I and II respectively).

## **3. Information by the Chair, the Delegations of the CDPC and the Secretariat**

- to take note of the information provided by its Chair, Mr Jesper Hjortenber, and the Secretariat on activities undertaken since the last CDPC Plenary meeting as well as recent developments of relevance to the work of the CDPC, including the outcome of the last CDPC Bureau meeting;
- to take note that the elections for the vacancies in the CDPC Bureau should in principle be carried out at the CDPC plenary meeting in December 2021;

## **4. Completed, ongoing and future activities of the CDPC**

### **a. Draft Terms of reference of the CDPC (2022-2025)**

- to take note of the information provided by the Secretariat relating to the draft CDPC Terms of Reference for the next four years (2022 – 2025), as prepared by the Secretariat and submitted for examination to the Bureau at its last meeting in March 2021 and then to the CDPC for written comments. These draft Terms of Reference, as well as those of all other Council of Europe committees, will be going through an internal procedure until final adoption by the Committee of Ministers after the summer break;
- to instruct the Secretariat to keep the members of the CDPC regularly informed of the internal procedure and when the draft Terms of Reference will be examined by the Committee of Ministers;

### **b. Action Plan on Smuggling of migrants**

- to decide that in order to start the implementation of the Action Plan on smuggling of Migrants (adopted in August 2020 and suspended due to the pandemic situation) the Chair and the Secretariat will discuss in September how to best implement the action n° 1 ("Addressing investigative, prosecutorial and judicial challenges in migrant smuggling-related cases") and report back to the plenary in December 2021;

**c. Protection of witnesses and collaborators of justice**

- to have an exchange of views with Mr Jesper Hjortenberg, Chair of the Drafting Working Group on the Protection of Witnesses and Collaborators of Justice (CDPC-PWCJ), who provided information about the deliberations of the 2nd meeting which took place on 7 May 2021, online;
- to take note of the updates, proposed by the Drafting Working Group, on Recommendation Rec (2005)9 on the protection of witnesses and collaborators of justice as well as of the information that the draft text is still not consolidated and another meeting of the Drafting Working Group is envisaged before the next CDPC plenary in December 2021;

**d. Hate Crime**

- to have an exchange of views with Mr Triantafillos Loukarelis, Chair of the CDADI, who provided information on the Committee of Experts on Hate Crime (ADI/PC-CH), as a subordinate body to the CDADI and the CDPC, including the deliverable - a new and comprehensive Committee of Ministers Recommendation on Hate Crime;
- to examine and take note of the ADI/PC-CH draft Terms of Reference valid from 1 January 2022 until 31 December 2023 and of the tasks and actions planned in them, which include inviting the members of the CDPC to appoint five representatives of the highest possible rank in the fields of equality, non-discrimination and inclusion policies, as well as in the criminal law and policy field, including crime prevention, victims' rights and criminal justice;
- to appoint Ms Stephanie Oener (Austria), Ms Corinna Tammenmaa (Finland), Ms Marion Adam (France), Ms Anne Postma (the Netherlands) and a representative from UK whose name will be provided to the Secretariat in due course.

**6. Council for Penological Co-operation (PC-CP) – Exchange of views with the Chair, Ms Annie Devos**

- to have an exchange of views with Ms Annie Devos (Belgium), the PC-CP Chair, regarding the past and planned work of the PC-CP;
- to note that two PC-CP WG meetings were held in a hybrid format in 2021 (on 3-4 February and on 11-12 May) and were attended remotely by more than 60 participants from about 20 member and observer states and to take note of the meeting reports: PC-CP(2021)1 and PC-CP(2021)10;
- to note that the PC-CP plenary meeting will be held on 22-23 November 2021 (hopefully in its usual format) and will start with a half-day Conference commemorating the 40th anniversary of its creation (22 November 1981). On its agenda will be a discussion of the management by prison and probation services of offenders with mental health disabilities and disorders as well as the ethical and organisational aspects of the use of AI by the prison and probation services;
- to take note that two questionnaires related to the mental health of offenders were sent out to the national prison and probation services and quite a high number of replies were received: See Docs. PC-CP(2021)4; PC-CP(2021)5 and PC-CP(2021)8 (preliminary quantitative analysis of the replies);
- to take note of Doc. PC-CP(2021)3: a scoping document of a future Committee of Ministers Recommendation on AI;

**a. Draft CM Recommendation regarding the assessment, management and reintegration of persons accused or convicted of a sexual offence and its explanatory report: Doc. PC-CP(2019)3Rev14**

- to thank the PC-CP for their excellent work and to examine, finalise and approve the draft Recommendation regarding the assessment, management and reintegration of persons accused or convicted of a sexual offence and its explanatory report which were amended in February 2021 by the PC-CP WG in the light of the comments and proposals made at the last CDPC plenary meeting in 2020. This is the 14th version of the text which was also commented upon by the following organisations and bodies: the International Association for the Treatment of Sexual Offenders (IATSO), the National Organisation for the Treatment of Abuse (NOTA), Les Centres Ressources pour les Intervenants auprès des Auteurs de Violences Sexuelles (CRIAVS), Netherlands Chapter of the Association for the Treatment of Sexual Abusers (NL ATSA), the Association for the Treatment of Sexual Abusers (ATSA), the European Forum for Restorative Justice (EFRJ) and the Consultative Committee of the Council of Europe Convention for the Protection of Individuals with regard to Automatic Processing of Personal Data (CETS No. 108);
- to instruct the Secretariat to submit the draft Recommendation to the Committee of Ministers for final adoption. The explanatory report is to be also transmitted to the Committee of Ministers for information;

**b. 25th Council of Europe Conference of Directors of Prison and Probation Services (CDPPS) (held in an online format on 9-10 November 2020 in Strasbourg) and 26<sup>th</sup> CDPPS (to be held on 20-21 September 2021 in Portugal)**

- to take note of the draft programme of the 26th Conference and of the fact that the outcome of the 25th CDPPS will be considered at the 26th CDPPS “Gaining an Edge over the Pandemic” which will examine among other topics the impact COVID-19 had on the mental health of offenders and staff as well as on the increased use of new technologies and AI by the prison and probation services;

**c. Request for observer status**

- to examine the requests for observer status to the Council for Penological Co-operation (PC-CP) made by i) the European Public Service Union (EPSU), ii) the International Corrections and Prisons Association (ICPA) and iii) the European Forum for Restorative Justice (EFRJ), as well as Doc. PC-CP(2021)2 containing a list of possible criteria for obtaining such a status with the PC-CP;
- to approve the general criteria for granting observer status which could be used for future such applications received by the CDPC and its subordinate committees;
- to approve unanimously the granting of observer status to EFRJ and to ICPA as contacts and cooperation with these organisations are already established and not to grant such a status to EPSU due to the lack of such contacts with the PC-CP;

**d. Items for information**

- to take note that all tasks contained in the current mandate of the PC-CP were fulfilled or will be fulfilled by the end of the current year and to take note of the draft terms of reference of the PC-CP for 2022-2025 and in particular of the tasks and actions planned in it;
- to take note that the SPACE I data for 2020 (related to prisons) were published on 8 April 2021 and that the SPACE II data for 2020 (related to probation) were published on 8 June 2021 and that both publications attracted as usual a lot of media attention;
- to take note that the SPACE team has collected and published on two occasions since the start of the pandemic data related to COVID-19 in prisons;

- to note that in the framework of the SPACE-related EU/CoE co-funded project, an online Conference "Three Decades of Crime and Criminal Justice Statistics in Europe: Methods, Trends and the Impact on Policy Making" took place on 22-23 March 2021. The publication of its proceedings as well as of the proceedings of the previous Conference held in the framework of the same project: "Measuring Cybercrime in the time of COVID-19: The Role of Crime and Criminal Justice Statistics" (29-30 October 2020) is expected by the end of 2021;

## **7. Artificial Intelligence and criminal law**

- to have an exchange of views with Mr Kristian Bartholin, co-secretary of the CAHAI (the Council of Europe Ad hoc Committee on Artificial Intelligence) on the recent developments and above all future projects and plans of this committee;
- to take note that at its last plenary meeting in November 2020, the CDPC decided to set up a Working Group to draft an instrument on Artificial Intelligence and Criminal Law following which the Bureau at its meeting in March this year finalised and approved the draft terms of reference of the CDPC Drafting Committee on the elaboration of an instrument on AI and criminal law related to vehicles and automated driving and decided to submit it to the CDPC plenary in June with a view to organising the first meeting of the Drafting Working Group after the summer break. The Bureau also appointed Mr Jesper Hjortenbergs as Chair of this Drafting Committee and invited Professor Sabine Gless to continue her work as the General Rapporteur/scientific expert of the Committee;
- to examine and approve the draft terms of reference of the CDPC Drafting Committee on the elaboration of a legal instrument on AI and criminal law related to vehicles and automated driving as prepared by the Bureau, with an amendment concerning the newly adopted Committee of Ministers Resolution on intergovernmental committees and subordinate bodies, their terms of reference and working methods CM/Res(2021)3;

## **8. Committee of Experts on the operation of European conventions on co-operation in criminal matters (PC-OC) – Exchange of views with the President ad interim, Mr Erik Verbert**

- to take note of the list of decisions of the 30th meeting of the PC-OC Mod (16-17 March) and the 79th plenary meeting of the PC-OC (4-6 May 2021);
- to have an exchange of views with the Chair ad interim of the PC-OC, Mr Erik Verbert, on the activities of the Committee;
- to congratulate the Federal Ministry of Justice and Consumer Protection of Germany on the successful organisation of the Conference on "Strengthening International Cooperation in Criminal Matters: extradition and mutual legal assistance" which was held on 5 May, under the aegis of the German Presidency of the Committee of Ministers;
- to take note with interest of the discussions held with the European Commission and the EPPO regarding co-operation with the European Public Prosecutor's Office under the European Convention on Mutual Assistance in Criminal Matters and the Additional Protocols thereto and the development of a protocol to provide a solid legal basis for this co-operation and to welcome the agreement reached on future steps to be taken;
- to note the development of proposals for the modernisation of the MLA Convention;
- to welcome the adoption of two new practical tools by the PC-OC: the model request form and guidelines on extradition and the model form for the exchange of judicial records;
- to take note of the special session planned in 2022 on asset recovery in cooperation with COP 198;

**9. Environment and Criminal Law – Exchange of views with the Chair of the Working Group, Mr Thomas Grégoire, and the scientific expert, Prof. Véronique Jaworski**

- to have an exchange of views with Mr Thomas Grégoire, Chair of the Working Group (WG) on the Environment and Criminal Law (CDPC-EC), who provided information about the outcomes of the deliberations of the 1st meeting of the Working Group, which took place on 20-21 April 2021, and the 2nd meeting which took place on 15 June 2021, online, and also to take note that more participants need to be nominated to take part in this WG;
- to take note that a third meeting of the WG is planned before the end of the year during which the scientific expert and the Secretariat will present an outline of a feasibility study of a possible future convention;
- to take note that one delegation requested that the WG discuss the possible added value of a new convention;

**10. Victims' rights – Exchange of views with Prof. Suzan van der Aa and Prof. Antony Pemberton**

- to have an exchange of views with Profs Suzan van der Aa and Antony Pemberton on their proposed update of Committee of Ministers Recommendation Rec(2006)8 on assistance to crime victims and to thank the consultants for their excellent work and proposals;
- to set up a Working Group to draft a recommendation on the rights of victims taking into account the rights and position of offenders and other persons involved in the criminal law process;
- to call on the interested delegations to appoint their representative to the WG which will start its work as soon as possible;

**11. Cybercrime Convention Committee (T-CY) – Exchange of views with Mr Alexander Seger, Secretary to the T-CY**

- to take note of the information provided by the Secretary of the T-CY, Mr Alexander Seger, regarding the state of play with the 2nd additional protocol to the Budapest Convention, which was approved by the T-CY in May this year and has now been sent by the Committee of Ministers to PACE for opinion. The adoption by the Committee of Ministers is expected in November this year and the opening for signature in March next year.

**12. Revitalising criminal justice work of the Council of Europe, with particular regard to Articles 5 and 6 of the European Convention on Human Rights. Proposal by the United Kingdom**

- to express its interest in the issue raised by the UK paper on Revitalising Criminal Justice Work of the Council of Europe (re-affirming the importance of the pre-trial protections in Article 5 and the principles of Article 6 of the Convention);
- to agree that the UK delegation should prepare a draft declaration (with input from other delegations, the Chair and the Secretariat) for consideration at the next Bureau meeting in October 2021 which will then report back to the CDPC plenary in December 2021;

**13. Information points**

- to take note of the information provided by the Secretariat on the information points a. to c.

**a. Medicrime**

**c. Council of Europe Convention on Offences relating to Cultural Property**

**14. Any other business**

- to reiterate the call for CDPC candidates to take part in the work of the new Drafting Committee on Trafficking for the Purpose of Labour Exploitation (DH-TET).
